Parliament's Financial and Economic Affairs Committee discussing introduction of corporate income tax

Local news has reported that the Parliament's Financial and Economic Affairs Committee (PFEAC) is studying to impose a law for corporate income tax on commercial establishments and companies in Bahrain. Once approved by the PFEAC, this proposal will be put up for vote in the Parliament's next session.

ZATCA announces that KSA Government will bear VAT due on private education services for citizens

On 4 September 2021, ZATCA announced that the KSA Government will bear the VAT due on private education services provided to citizens. We have summarized in the table below which type of institution the exemption of VAT will apply to.

SN	Type of institution	Scope of exemption
1	Private and international schools accredited by the Ministry of Education (MoE)	<ul style="list-style-type: none"> - Tuition fees; and - Textbooks sold directly by private and international schools and approved by the MoE
2	Private universities (for bachelors) that fall under the supervision of the MoE	<ul style="list-style-type: none"> - Tuition fees; and - Textbooks sold directly by the university
3	More than 2 years educational and training programs supervised by the Technical & Vocational Training Corporation	<ul style="list-style-type: none"> - Tuition fees; and - Textbooks sold by accredited educational authorities as part of the educational program

General Tax Authority (GTA) further extends the deadline for filing income tax return for tax exempt entities

GTA announced the extension of the deadline for submitting the income tax return in relation to the tax year ended 31 December 2020 for tax exempt entities under the income tax law. The extended deadline is now 31 December 2021 instead of 31 August 2021.
