Elmore Ltd ACN 057 140 922 (Administrators Appointed) (Receivers and Managers Appointed) And subsidiaries as set out in Annexure A (Collectively referred to as "the Elmore Group" or "the Group")

I refer to previous correspondence in relation to the Elmore Group.

At the Reconvened Second Meeting of Creditors held on 26 July 2024, creditors of the Elmore Group, resolved to accept the Deed of Company Arrangement (**DOCA**) as outlined in the Administrators Supplementary Report to Creditors dated 18 July 2024.

I confirm that the DOCA was executed on 16 August 2024. As a result, the Administrators have now retired and become the Deed Administrators of the Group. The Receivers and Managers remain in control of the Group.

The DOCA operates for a fixed period of 60 days from commencement (unless extended) and during this period, the Deed Administrators will

- conduct further investigations into the affairs of the Group, for the purposes of maximising funds available for distribution to creditors; and
- seek proposals for the restructure or rearrangement of the Group's business, property and affairs; and
- report to creditors, including by providing a report within 60 days of from the date of when the Group entered into the DOCA (i.e. by 15 October 2024).
