### INTERLOCUTORY ORDER

- 1. The interlocutory applications made by:
  - (a) Andrew Phillip Whitehead and Marlene Whitehead (as trustees for the Beeline Trust) and Andrew Phillip Whitehead ("Whitehead Group");
  - (b) Fiona McMullin; and
  - (c) Chen Wang,

were determined by the Honourable Justice Venning on 3 April 2020.

- The determination was made following a hearing held on 3 April 2020. A Leopold SC (Aust), E Holmes and M Kersey appeared for the Applicants, E L Smith appeared for the Whitehead Group, S Munro appeared for Fiona McMullin and Chen Wang, E A J Hyde appeared for Choo Boon Loo, J V Gooley appeared for Elysium Business Systems Pty Limited, C Mitchell appeared for Jason Paul Hingston and J C Caird appeared for Atlas Asset Management Pty Ltd (ACN 607 442 679) as trustee for the Atlas Asset Management Trust. Professor John Knight and Rosalie Bouwmeester appeared in person.
- 3. The following orders were made:

### Joinder of Respondents

- (a) Pursuant to rules 4.23(3) and 4.24 of the High Court Rules 2016 ("Rules"), Fiona McMullin be added as the fifth Respondent and appointed to represent all clients of Halifax Investment Services Pty Ltd (In Liquidation) ("Halifax Australia") and all clients of Halifax New Zealand Limited (In Liquidation) ("Halifax NZ") who invested before 1 January 2016 in order to propound the argument that investments made before there was a deficient mixed fund are traceable.
  - Pursuant to rule 4.56 of the Rules, Andrew Phillip Whitehead and Marlene Whitehead in their capacity as Trustees of the Beeline Trust and Andrew Phillip Whitehead be added as the sixth and seventh Respondents, noting the Court's intention to manage the proceedings so as to avoid, as far as possible, duplication of costs arising from the joinder of the sixth and seventh respondents, and, in particular, to avoid duplication to the extent that the interests of the sixth and seventh respondents correspond with the interests of a representative respondent.

## Costs of Fifth, Sixth and Seventh Respondents

- (c) The representative Respondent appointed pursuant to Order (a) be indemnified in respect of her legal expenses reasonably incurred in so acting, such expenses to be paid out of the Accounts (as that term is defined in paragraph 1(b)(i) of the Originating Application for Directions dated 25 September 2019), as agreed by the Liquidators or taxed.
- (d) In relation to the sixth and seventh Respondents appointed pursuant to Order (b), their reasonable costs and expenses, in:
  - (i) bringing the Interlocutory Application dated 4 February 2020; and
  - (ii) participating in these proceedings,

be reserved pending resolution of all substantive matters.

## Costs of Chen Wang

(e) An order for costs in the sum of NZ\$12,448.50 in favour of Mr Chen Wang, to be paid out of the Accounts (as that term is defined in paragraph 1(b)(i) of the Originating Application for Directions dated 25 September 2019).

- (j) Any agreed Statement of Facts be filed and served by 14 September 2020.
- (k) Applicants' written submissions be filed and served by 28 September 2020.
  - Respondents' written submissions, confined to the issues identified in the list of issues filed by the relevant Defendant in accordance with Order 5, be filed and served by 26 October 2020.



- (m) Applicants' written submissions in reply be filed and served by 16 November 2020.
- (n) The parties file and serve lists of authorities 7 days before the hearing.
- (o) The hearing on the originating application dated 25 September 2019 be set down on 30 November 2020, with an estimate of up to two weeks.
