## Notice to Creditors

On 7 April 2025, the Administrators filed an originating process in the Supreme Court of New South Wales (**Application**) in relation to the external administration of the Companies.

The Application relates to two aspects of the external administration:

1. extending the statutory convening period for the second meetings of creditors of the Australian Jervois Companies from 9 April 2025 to 30 April 2025 (**Extension of Time**); and
2. granting orders justifying the Administrators' entry into an Implementation Deed and a proposed Accession Deed, and limiting the Administrators' personal liability which may arise as a result of them entering into the Accession Deed (**Limitation of Liability**).

On 8 April 2025, Justice Black of the New South Wales Supreme Court made Orders:

1. extending the statutory convening period in relation to the Australian Jervois Companies to 30 April 2025, with an order that the Administrators can convene the second meetings at any time before then (with any meeting requiring 5 business days' notice to creditors); and
2. making directions listing the Limitation of Liability for a hearing before Justice Dixon at **10am** on Thursday **10 April 2025 (Adjourned Hearing)**.

Orders relating to the Limitation of Liability will be sought at the Adjourned Hearing.

The Orders also provide that any party who can demonstrate sufficient interest in the Application has liberty to apply at the Adjourned Hearing.
