**ORDERS OF ACTING MASTER MCDONALD
MADE ON 31 AUGUST 2023**

UPON THE APPLICATION of the plaintiffs by Originating Process dated 25 August 2023 AND UPON HEARING Mr L Ayres counsel for the plaintiffs AND UPON READING the affidavit of Matthew David Woods sworn 25 August 2023 and the affidavit of Linda Diep sworn 31 August 2023 IT IS ORDERED THAT:

1. Pursuant to section 439A(6) and section 447A of the Corporations Act 2001 (Cth) (Act) the period within which the Plaintiffs must convene the second meeting of creditors in respect of Kalium Lakes Ltd (Receivers and Managers Appointed) (Administrators Appointed) (ACN 613 656 643) (Kalium Lakes), Kalium Lakes Infrastructure Pty Ltd (Receivers and Managers Appointed) (Administrators Appointed) (ACN 631 042 450) (Kalium Lakes Infrastructure) and Kalium Lakes Potash Pty Ltd (Receivers and Managers Appointed) (Administrators Appointed) (ACN 601 436 060) (Potash) under section 439A of the Act (Second Meetings) be extended to 1 December 2023.
2. Pursuant to section 447A(1) of the Act, the application of Part 5.3A of the Act is to operate in relation to Kalium Lakes, Potash and Kalium Lakes Infrastructure such that notwithstanding section 439A(2) of the Act, the Second Meetings must be held at any time before, or within five business days after the end of the convening period as extended by paragraph 1 of these orders and the Second Meetings may be held together or separately at any time during that period.
3. The costs and expenses of this application be costs and expenses in the administration of each of Kalium Lakes, Potash and Kalium Lakes Infrastructure and paid out of their respective assets.
4. The Plaintiffs give notice of these orders by way of circular to the Committees of Inspection of Kalium Lakes and Potash and creditors of the Companies within one (1) business day of the date of these Orders.
5. Any creditor or interested person may apply to vary or discharge the Orders on three (3) business days' notice to the Plaintiffs and the Court.
6. The Plaintiffs have liberty to apply.
