## A. DETAILS OF APPLICATION

This application is made under sections 439A(6) and 447A.

The Plaintiffs seek an extension of the convening period in relation to the administration of each of Nuheara Limited (Administrators Appointed)(ACN 125 167 133) and its subsidiaries Nuheara IP Pty Ltd (Administrators Appointed)(ACN 605 704 096) and Terrace Gold Pty Ltd (Administrators Appointed)(ACN 072 608 704) (collectively, the "Companies") to facilitate steps by the Plaintiffs to recapitalise the Companies and/or realise the business or assets of the Companies for the benefit of their creditors and associated relief.

On the facts stated in the supporting affidavit(s), the plaintiff claims:

- 1. An order pursuant to section 439A(6) of the Corporations Act 2001 (Cth) (Act) that the convening period for the purposes of the second meeting of the creditors of each of Nuheara Limited (Administrators Appointed) ACN 125 167 133, Nuheara IP Pty Ltd (Administrators Appointed) ACN 605 704 096 and Terrace Gold Pty Ltd (Administrators Appointed) ACN 072 608 952 (together the Companies) under section 439A(5) (b) of the Act be extended to midnight on 11 December 2024 (the Extended Convening Period).
- 2. An order pursuant to section 447A of the Act, that Part 5.3A of the Act is to operate in relation to each of the Companies as if the meeting of creditors of the Companies required by s 439A of the Act may be held at any time during the Extended Convening Period or the period of five business days after the end of the Extended Convening Period, notwithstanding the provisions of s 439A(2) of the Act.
- 3. The Plaintiffs have liberty to apply to the Court for any further extensions of the convening period of the Companies, and such application may be made at any time during the Extended Convening Period.
- 4. The Plaintiffs provide a copy of these orders to all creditors of the Company within 2 business days after they are made, by uploading them to the creditors' portal and by sending them to creditors (by email to those creditors for whom the Plaintiffs have an email address).
- 5. Any person has leave to apply to vary these orders upon 3 business days' notice to the Plaintiffs.
- The costs of this application be costs in the administration of the Companies, and be paid out of the assets of the Companies.


