We advise that due to insufficient cash resources to continue business operations and the inability to achieve a sale of the business and transition of employees, the Company will cease trading with immediate effect from Monday, 13 August 2018.

We draw your attention to the following information:

**1 Joint venture projects**

It is our understanding that any Joint Venture projects that York Civil is a party to, will be continued by the remaining Joint Venture partners. In particular, arrangements have been made for a continuation of works on the North Terrace Tram Extension, Torrens to Torrens upgrade and the Swan River Pedestrian Bridge.

**2 Company projects**

All Company projects will cease with immediate effect.

**3 Goods subject to purchase money security interests and liens / pledges / property used but not owned by the Company**

In accordance with Section 443B of the Act, the Voluntary Administrators' liability under hire purchase or lease agreements does not commence until seven days after the Voluntary Administrators' appointment.
