Annexures

 - c) The pages in an annexure must be numbered consecutively.
- C. If a form has a document annexed the following particulars of the annexure must be written on the form:
 - a) the identifying mark; and
 - b) the number of pages.
- D. A reference to an annexure include a document that is with a form.
