

### Belgian immigration: Principles

#### - Principle:

- For every non-EEA national working in Belgium as an <u>employee</u>
  Belgian work permit/Belgian Single Permit
- Independent whether working for Belgian or non-Belgian employer
  Belgian Professional Card



#### — 原則:


- ベルギーで<u>従業員</u>として働くすべての非EEA国民 ベルギー労働許可/単一許可証
- ベルギー/非ベルギー人雇用主に関わりなく<u>独立事業主</u>として労働 ベルギープロフェッショナルカード





# Single Permit - Principle


- Single Permit Directive: as from 1 January 2019
- Aim: increase the employment mobility of non-EEA nationals to Europe
- Three regions very well implemented the directive
- Still a lot of differences in the delays (Flanders longest processing times for first part)






### 単一許可証-原則

### Professional card

- Third country national
- Self-employed professional
  - either as a physical person OR
  - Within an existing company
- ⇒ Requires a professional card (unless an exemption is applicable, e.g. business visitor)
  - To submit in home country (if not living in Belgium)
  - To submit in Belgium (if already legally living in Belgium)
- ⇒ Economic condition is very important
- ⇒ Combination Single Permit with Professional card is possible
- ⇒ Rules are different per region
- ⇒ In principle initial card is valid for 2 years
  - ⇒ Afterwards, extension possible with a maximum of 5 years validity of the card (renewable)
- ⇒ NEW: Flanders has implemented recent change in their legislation



### プロフェッショナルカード

- 第三国民が対象
- 自営業者
  - 個人事業主として もしくは
  - 企業内勤務
- ⇒ 原則的にプロフェッショナルカードが必要(短期出張等の一部例外あり)
  - 自国から申請 (ベルギー居住者ではない場合)
  - ベルギーから申請 (ベルギー居住者の場合)
- ⇒ 経済的条件が極めて重要
- ⇒ 単一許可証との連携も可能
- ⇒ **地域毎に異なる**申請ルール
- ⇒ 初回申請は原則2年
  - ⇒ その後、5年間の延長申請可
- ⇒ フランダース地域は関連法律変更を実施



# Unique Counter - Uniek Loket - Guichet Unique

Since mid-June 2021 Single Permits only (for the moment) No option via e-mail/paper Easy – administrative burden reduces One location – approvals – request for info Mandate required Future: work permit B
