Filing of the Economic Substance (ES) returns for fiscal year 2020 will be from 8 August 2021 to 12 September 2021

On 10 August 2021, Ministry of Industry Commerce and Tourism (MoICT) issued circular number FAEI/11/MSJ/2021 stating that the filing period for ES returns for the fiscal year end of 2020 will be from 8 August 2021 to 12 September 2021.

Entities that fail to comply with the filing period will be subject to the violations and sanctions, which includes suspension of the CR, trader strike off, fines, and referral to public prosecution.
