The GCC launches E-Platform for trade between GCC member states and internationally

The new electronic system was launched to ease the trade procedures between the GCC member states and other countries under a new Free Trade Agreement. The GCC member states are aiming to achieve to trade as a unit and increase their international trade share from 5% to 30% by 2028. The expected start is either by the end of 2021 or the first quarter of 2022.

The president of the GTA Ahmed Bin Issa Al Mohannadi has recently confirmed that the GTA does not have the intention to introduce income tax. However, the introduction of VAT is still being considered.
