EMPLOYEE WELLNESS PROGRAMME

Our employee wellness programme has been designed to support as many of our staff as possible to enhance their overall health and wellbeing. EMPLOYEE ASSISTANCE PROGRAMME

Our staff are entitled to free and confidential personal counselling services through a local independent counselling organisation. The programme is fully financed by the firm, and offers assistance to KPMG employees and their families in a wide variety of areas.

ANNUAL STAFF GOLF DAY

Our staff golf day is held annually in October, and usually amidst clear skies and sunshine. Open to all staff from all skill levels, KPMG golfers are placed into randomly selected foursomes on the day, giving participating staff the opportunity to get to know one another, network, and forge new friendships outside of the office.

ANNUAL CHILDREN'S CHRISTMAS PARTY

On December 18, 2017, the firm once again held its annual Children's Christmas party, complete with crafts, games, presents, and a visit from Santa. Each year, KPMG staff are invited to bring their children to share in the fun and magic of the holiday season during this highly anticipated event.

Our Youth Focused Initiatives

KPMG ROUND THE GROUNDS RACE

On Sunday, March 19, 2017 over 500 participants of all abilities and aged from 4 to 18 took part in the annual KPMG Round the Grounds Junior Running Race in the Botanical Gardens.

KPMG INVESTMENT CHALLENGE

As part of our ongoing commitment to education and youth development, KPMG in Bermuda launched the Senior School Investment Challenge in 2005. Under the terms of the investment club-like initiative, participating schools are given \$50,000 in virtual funds to trade over the course of 6 months. At the end of the programme, real cash prizes totalling \$20,000 are awarded to the schools of the first, second and third placed teams. The core objective of the Challenge is to create a meaningful and perpetual educational programme for Bermuda's Senior Schools.

KPMG FRONT STREET MILE

KPMG in Bermuda works in partnership with the Bermuda National Athletics Association and the organisers of the Bermuda Marathon Weekend to stage the selection trials and the finals of the KPMG Bermuda Invitational Mile in January each year. This initiative attracts students aged 8 to 18 from all local schools, who vie for the opportunity to participate in the international event. The students get the opportunity to meet and train with elite runners from around the world.

Virtual Enterprise International Competition

For the second year KPMG employees across the firm are serving as mentors for students at The Berkeley Institute. Their Virtual Enterprises International class involves running a company on a virtual platform and competing with almost 2000 students worldwide. The Berkeley Institute students have formed a company called "Vacations in Paradise Enterprises" (VIP) which sells holiday packages and bundles to Bermuda.

VIP has all the elements of an authentic corporation with the required departments such as Finance, HR, and Marketing and students are placed in positions throughout the company; CEO, VP's, etc. The students must submit projects and make pitches in order to be graded. The class culminates in a trade show in New York City next May where the students will sell their products. KPMG mentors regularly visit the school and are coaching the students on presentation skills, writing their business plan, balancing budgets, compiling an employee manual, as well as assisting with, and attending, an open house they held to raise funds for the upcoming trip.

Our Student Internship Programme

KPMG in Bermuda hosts biannual K-Nect student events as well as a Parent & Teachers' K-Nect Information evening. At these events, parents, teachers and students are able to find out how KPMG in Bermuda can help shape students' interest in business and financial services into a rewarding career. In addition, the opportunities offered in terms of summer internships and the annual KPMG Scholarship are presented.

Our 2017 Summer Interns started their first week with Audit training followed by a two week project for seven local non-profit organisations.

Here's a selection of activities our interns were involved with:

- Proposing an America's Cup Business Plan for R/V Endurance;
- Cleanse current email database and deliver solution for automated maintenance;
- Producing a survey and reviewing files to create statistical graphs;
- Development of a new volunteer/membership/contact database; updating referral booklet for distribution to clients;
- Research and develop a data base system; creating a procedures manual; creating payroll spreadsheets to run monthly payroll and data entry; and
- Establish an electronic client database; inventory of residential supplies and recording systems.

The projects provided the students the opportunity to use their initiative and creativity, with a mentor system in place, and allowed them to improve on their presentation skills as they delivered their findings and recommendations to KPMG's management and staff, and the Senior Executives from the various charities.

As a separate project, the KPMG Interns participated in the Centre of Philanthropy's Summer Intern Community Day held on July 14, 2017.

Supporting and Encouraging Road Safety - "A Piece of the Rock"

After months of witnessing and dealing with the aftermath of preventable vehicular accidents following his arrival in Bermuda, and particularly that of a close colleague and friend, KPMG in Bermuda Actuary, Agam Jain decided to do something about the problem of drink-driving, careless riding, and the cultural causes that underlie the island's startling road accident rates.

Using his long-held interest in film as a catalyst, Agam embarked on a year-long journey to fund and produce "A Piece of the Rock", a documentary highlighting world-leading instances of road crashes in Bermuda and their socio-economic impact on the island's population.

With a focus on youth and young riders, Agam approached various agencies and companies to secure funding for his project, with KPMG signing on as an early and leading contributor. Aside from the financial contribution, the firm also gave Agam a sabbatical from his Actuarial duties to pursue nine months of shooting and administration for the film. Over this time, Agam and his associates collected sponsorships, government backing, raw footage from ambulances and trauma room at the ER, and interviews with survivors, family members and the general Bermudian public.

The film was shown to our staff at KPMG offices, followed by a panel discussion made of Manish Thareja (creative co-producer), Doctor Joseph Froncioni (former chair of Bermuda Road Safety Council and Orthopedic surgeon) and Alison Bardgett (chair of Bermuda Road Safety Council).
