1. On June 12, 2024, Pioneer Balloon Canada Limited. ("Pioneer Balloon" or the "Company") filed a Notice of Intention to Make a Proposal ("NOI") pursuant to Subsection 50.4(1) of the *Bankruptcy and Insolvency Act* and KPMG Inc. was named as trustee under the Company's NOI.
2. The Company failed to file a proposal on or before August 16, 2024, and as a result, the Company was deemed to have made an assignment in bankruptcy on August 19, 2024. KPMG Inc. was appointed as Trustee (the "Trustee") of the Estate of the Bankrupt by the Official Receiver, subject to affirmation by the creditors of the Trustee's appointment or substitution of another trustee by the creditors.
3. The first meeting of creditors of Pioneer Balloon will be held on September 5, 2024 at 10:00 A.M. EST using the Microsoft Teams platform. Conferencing details will be made available upon request.
4. Enclosed with this Notice is (i) a condensed statement of the Company's assets and liabilities, including a list of creditors showing the amounts of their claim (as per the Company's records), (ii) a form of proof of claim, and (iii) a form of proxy.
5. To be entitled to vote at the meeting, a creditor must file with the Trustee, before the meeting, a Proof of Claim and, where necessary, a Proxy. 
