

## **SCOTSBURN CO-OPERATIVE SERVICES LIMITED – CALL FOR CLAIMS**

As required by Section 44 of the *Co-operative Associations Act, R.S., c. 98, s. 1* (the “**Act**”), Scotsburn Co-operative Services Limited (“**Scotsburn**”) passed a Special Resolution to wind up and dissolve the co-operative. Pursuant to the Act, KPMG Inc. has been appointed Liquidator of Scotsburn (the “**Liquidator**”).

As you may be aware, the sale of substantially all of the assets and liabilities of Scotsburn and its subsidiaries to Agropur was completed effective as of January 31, 2017. As part of that transaction, Agropur assumed the majority of Scotsburn’s operating liabilities that were outstanding as of the date of the sale. Those amounts have been or will be paid by Agropur in the normal course.

This notice is being published pursuant to the Act in order to notify all potential creditors of Scotsburn and others having claims thereon that the Liquidator is holding a call for claims in order to identify any liabilities of Scotsburn that were not assumed by Agropur. As the Act requires the claims bar date (i.e. the date on or before which creditors of Scotsburn having claims thereon are to send in their claims) to be at least two months following the initial notice of the call for claims, the claims bar date has been set for May 24, 2017.

**Only those creditors and other parties with potential claims against Scotsburn that have not been assumed by Agropur are required to submit a proof of claim form (“Proof of Claim”). Proofs of Claim must be submitted to the Liquidator for any claim against Scotsburn, whether unliquidated, contingent or otherwise.**

**Completed Proofs of Claim must be received by the Liquidator by no later than 5 p.m. (Atlantic Standard Time) on May 24<sup>th</sup>, 2017. It is your responsibility to ensure that the Liquidator receives your Proof of Claim by the above-noted time and date.**

**TAKE NOTE THAT FAILURE TO SEND IN A PROOF OF CLAIM BY MAY 24<sup>th</sup>, 2017 WILL RESULT IN DISTRIBUTIONS BEING MADE WITHOUT REGARD TO ANY CLAIM NOT RECEIVED BY THAT DATE.**
