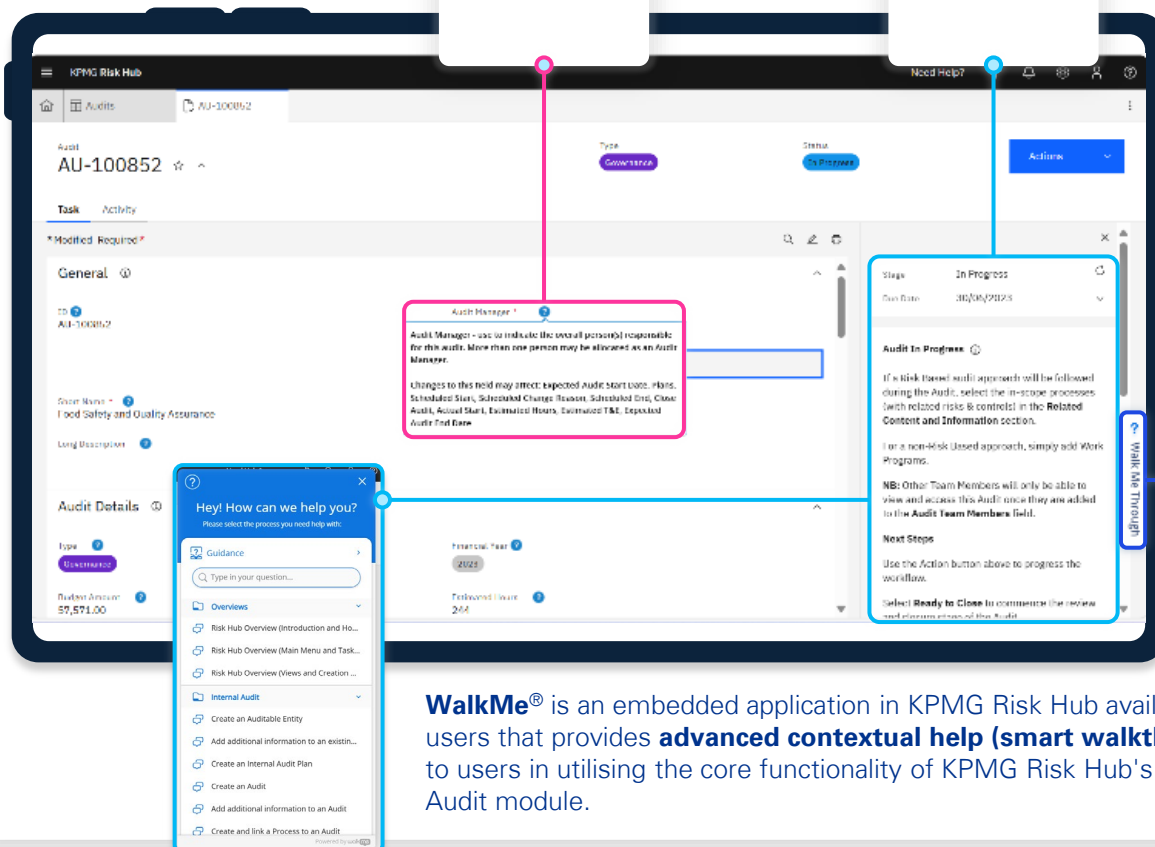

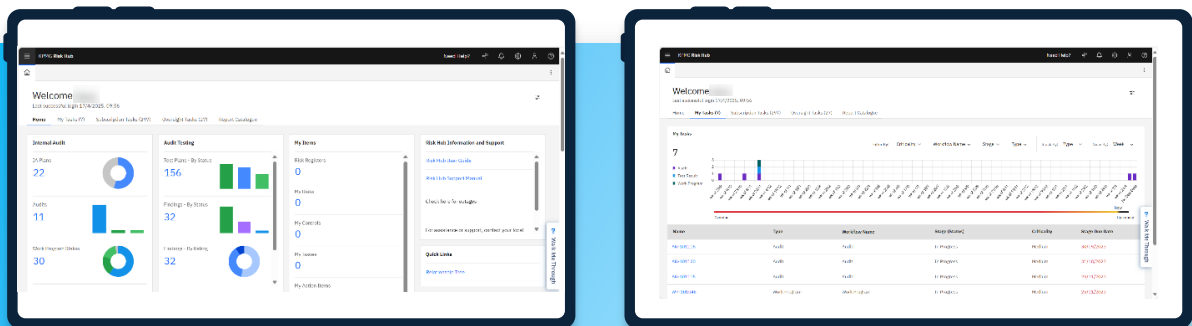

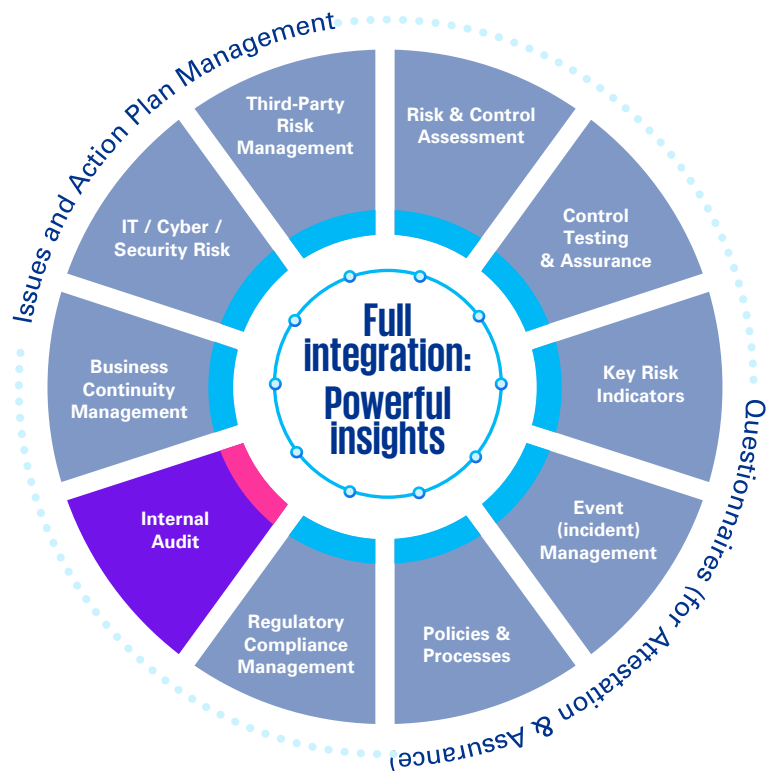


Integrated modules
