Customer challenges



- Accounts Payable (AP) process was relocated from SSC (nearshore) back to headquarters (onshore)
- 30 AP resources in headquarters had to manage the workload managed by previously 150 resources
- High manual workload for invoice processing and booking
- · High amount of non-PO invoices
- Invoices contain many handwritten notes, causing standard OCR technologies to be insufficient
- Other document formats than invoices
- Heterogeneous posting quality and errors due to manual processing




- Proof of Concept for development and training

- Continuous monitoring and enhancement of the solution
