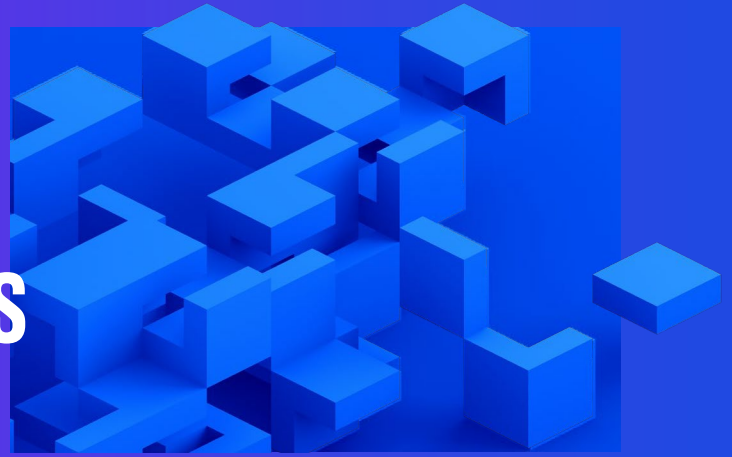

Cash flow forecasting

Insolvent liquidations
