

1. British Citizens

British registration



What do I need to do?

As a British citizen, and based on the UK withdrawal agreement, you will need to get a foreign identity card.



When?

It needs to be done upon your arrival to Spain*.



Process

- Online Application at the immigration website
- Police appointment
- Meeting at the Police Station

Timeline

The whole process if approved, to get your foreign identity card (TIE) may take up to 4 months.

*This process only applies to British citizens who do not already hold a Certificate of European Union Citizenship and have entered Spain before the end of the year (31.12.2020).

2. EU spouse

EU Citizens registration



What do I need to do?

As an EU citizen, your spouse is entitled to live and work in Spain. However, a registration process needs to be followed for your spouse. This process of EU Registration or Certificate of European Union Citizenship is compulsory for all European citizens who are going to live or work in Spain for a period of more than 3 months.



When?

Normally it can be done simultaneously with your own registration.

Process

- Get an appointment at the Police Station.
- The spouse needs to go to the Police Station and submit the corresponding documents.
- Meeting at the Police Station (a KPMG expert will assist you).

KPMG can take care of the police appointment as well as assist you to prepare the necessary documents for both process.

At the police meeting a KPMG expert would assist your spouse.



Timeline

Normally your spouse will obtain the Certificate of the European Union Citizenship (a green ID shaped card without a photo or signature and with the NIE on it) the same day of the interview.

2. British spouse

UK citizens process



What do I need to do?

As UK citizen, and based on the UK withdrawal agreement, your spouse will need to get a foreign identity card.



When?

It needs to be done upon your spouse's arrival to Spain*.



Process

Timeline

The whole process if approved, your spouse will get a foreign identity card (TIE). It may take up to 4 months to get it since approval.

*This process only applies to British citizens who do not already hold a Certificate of European Union Citizenship and have entered Spain before the end of the year (31.12.2020).

2. Third country national spouse



What do I need to do?

As a foreign citizen your spouse will need to get a family member card of a British citizen.



When?

It needs to be done upon your spouse's arrival to Spain with you.

Process

- Online Application

At the police meeting a KPMG expert would assist your spouse.



Timeline

The whole process if approved, a foreign identity card (TIE) is obtained. It may take up to 6 months to get it.

3. Special considerations for non-married couples

If your partner is an EU or UK* citizen

Your partner will need to prove:

- Sufficient economical means.
- Private health insurance in Spain.



*This process only applies to British citizens who do not already hold a Certificate of European Union Citizenship and have entered Spain before the end of the year (31.12.2020).

If your partner is a third country citizen

Your partner will need to prove:

- The existence of a relationship.
- Sufficient economical means.
- Private health insurance in Spain.
