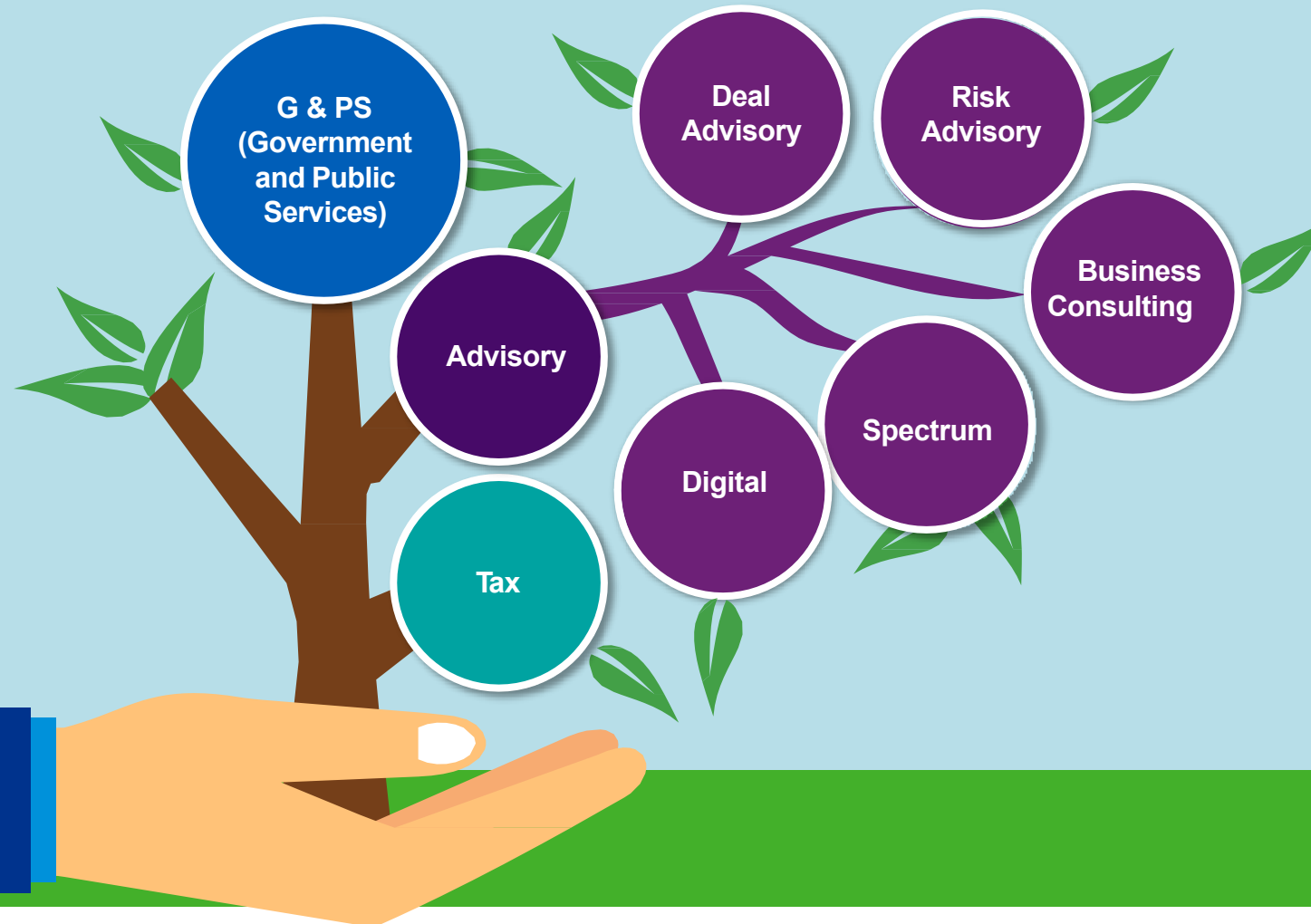

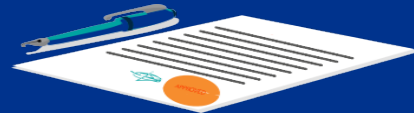

# Guidelines for KIC participation and general questions



How many members must each team have to participate?

Teams can only compete in groups of four to six students with members currently enrolled in a STEM (science, technology, engineering and math) and business courses



How are teams formed?

You and fellow students can form a team comprising at least one male and one female member



What is the eligibility criteria to participate in KIC in India?

Students currently enrolled in a full-time undergraduate/bachelors/post graduate degree with at least one year remaining of their studies



Can I form a team with someone who does not meet the eligibility criteria?

Everyone in the team has to meet the eligibility criteria



What's in it for me?

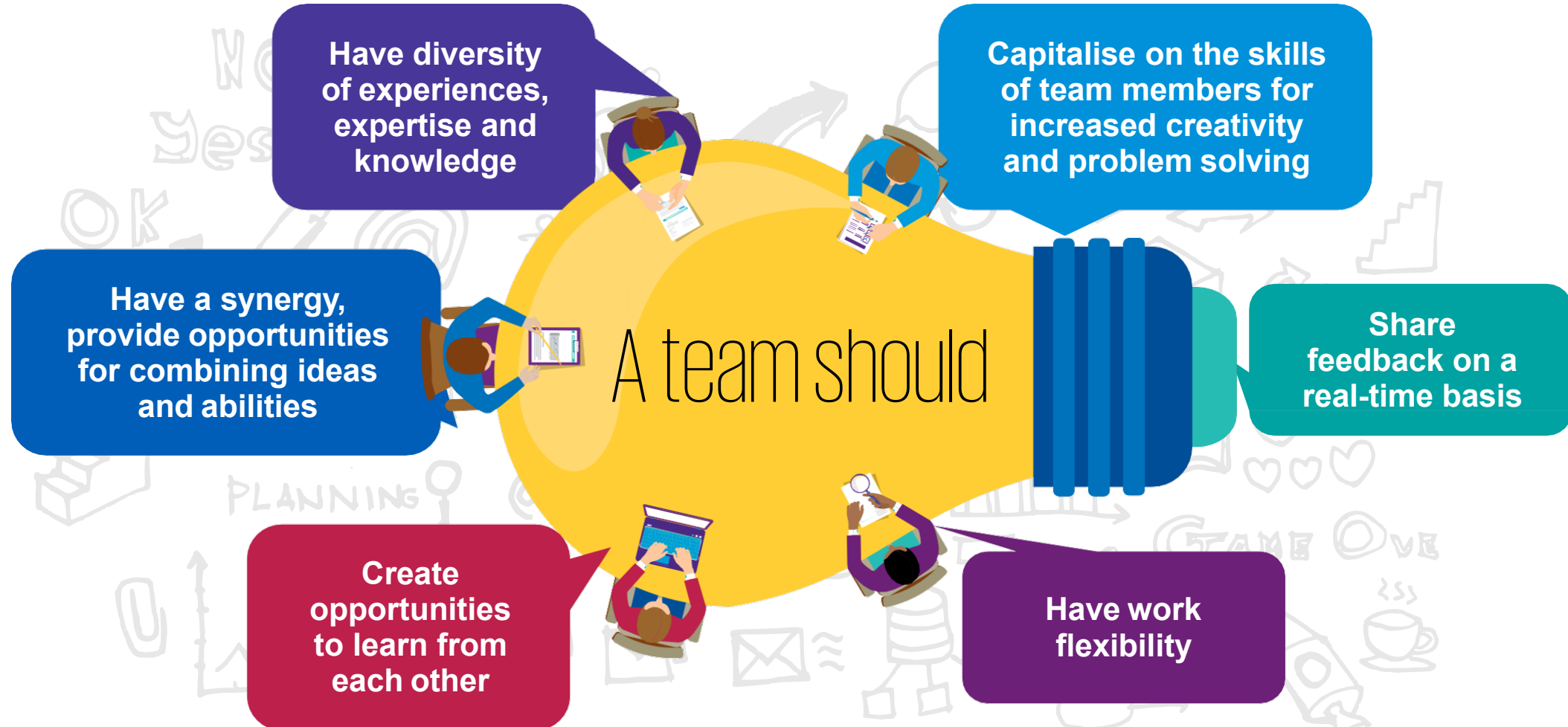
