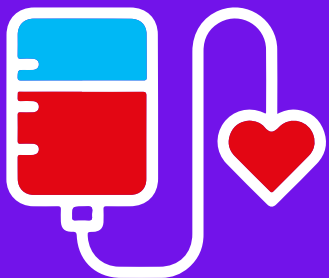

The CSI committee also used the occasion to create awareness among staff on the plight of the national blood bank and the health benefits of donating blood.

To support the next generation of entrepreneurial leaders, as is our tradition, KPMG Kenya staff participated in the 20th Enactus Kenya National Expo competition from 20 July to 23 July, as League Managers and Judges. The expo attracted about 1000 university students drawn from 25 public and private universities in Kenya who showcased a wide range of social enterprise projects. 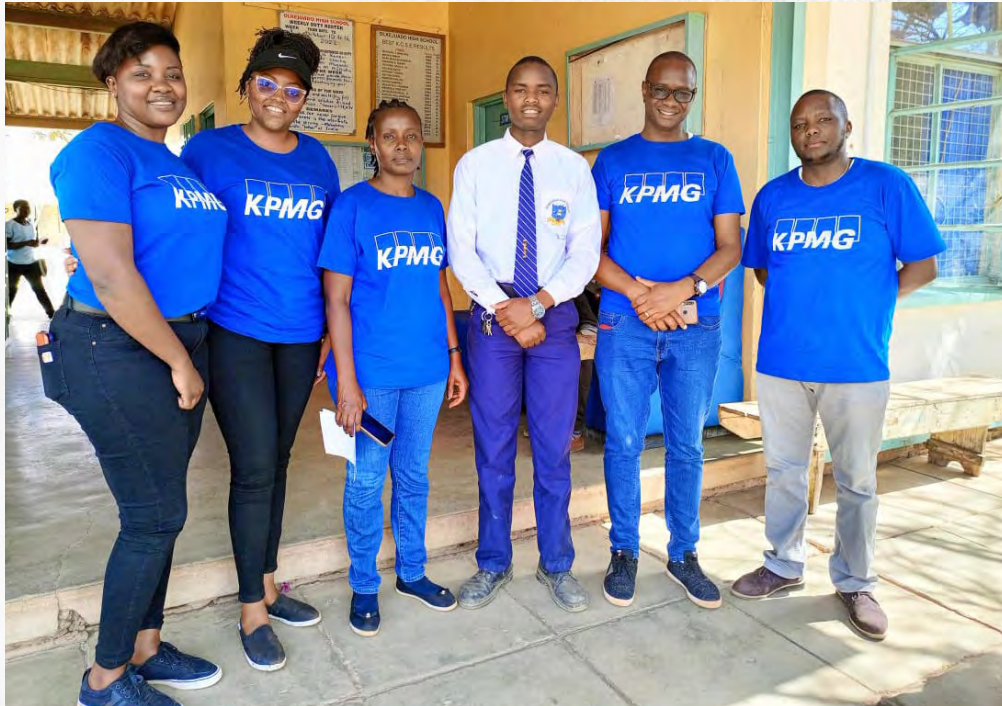




Mentoring to influence a generation
