Additionally, the position requires collaboration with various stakeholders, including the Ministry of Health, Ministry of Education and Ministry of Ministry of Community Development, Gender, Women and Special Groups to enhance program outcomes and sustainability.

Key roles and responsibilities

- Support the preparation and review of program progress reports and mid-year reviews in collaboration with program directors
- Analyze and evaluate the effectiveness all projects, and make recommendations to improve project outcomes
