

## Cessation of E-VAT Refund System

*(Notification No. 26892 GDT, dated 7 December 2020)*

The General Department of Taxation (GDT) has issued Notification No. 26892 dated 7 December 2020, to inform all taxpayers that E-VAT Refund System as per previous instruction no. 001 MEF dated 9 January 2019 shall cease to function starting from 1 January 2021.

Thus, taxpayers who would like to request for a VAT refund starting next year shall use E-VAT Refund function through the E-Filing system for monthly tax returns which will be implemented from 1 January 2021.

### Our comments

With this Notification, taxpayers only have the option to use the GDT's E-filing system to request for VAT refund moving forward after 1 January 2021.
