



Customs – List of Prohibited and Restricted Goods

Royal Government of Cambodia – Sub-Decree No. 17 dated 26 February 2020 on the List of Prohibited and Restricted Goods

This Sub-Decree aims to update the list of prohibited and restricted goods as mentioned in the Annexes to the Sub-Decree and in accordance with the Customs Tariff of Cambodia 2017.

The Ministry of Economy and Finance (MoEF) shall update the commodity codes of the goods in the Annexes based on the changes to the Harmonized System (HS) of the World Customs Organization (WCO) and changes in the ASEAN Harmonized Tariff Nomenclature (AHTN).

In the case of risks that require urgent measures, relevant competent ministries may take temporary measures to control the export, import or transit of risky goods, even if those goods are not included in this Sub-Decree. The duration to implement such measures must be clearly stated and be for not more than six (6) months. These temporary measures may be terminated before the specified end date or delayed according to the actual situation.

This Sub-Decree consists of five (5) annexes: (1) list of prohibited goods, (2) list of goods that require export/import permits, (3) list of goods that require permits from the exporting country, (4) list of goods that require international transit permits; and (5) explanation notes, including definitions, notes and how to read the lists.

Sub-Decree No. 209 dated 31 December 2007 on the List of Prohibited and Restricted Goods and Sub-Decree No. 208 dated 8 September 2011 on the Amendment of Note II in Annex 2 of Sub-Decree No. 209 and any regulations contrary to this Sub-Decree No. 17 shall be null and void.

Sub-Decree No. 17 is effective from 1 April 2020 onwards.

Commerce – Amendment to Public Service Fees of the Ministry of Commerce (MoC)

Inter-Ministerial Prakas No. 333 dated 27 March 2020 on the Amendment to Public Service Fees of the MoC

Some MoC public service fees have been decreased, effective from 1 April 2020. The following are the amended public service fees under the Department of Business Registration of the MoC:

- The registration fee for a commercial company, including a foreign branch office and commercial representative office is decreased from 1,680,000 Riels (~US\$420) to 1,010,000 Riels (~US\$252.5)

- The registration fee for a sole proprietorship is decreased from 300,000 Riels (~US\$75) to 180,000 Riels (~US\$45)
- The fee for checking and booking the availability of an enterprise's name for registration is decreased from 40,000 Riels (~US\$10) to 25,000 Riels (~US\$6.25).

Any regulations contradict to this Prakas shall be null and void.
