

Labor – New Corporate Bank with the NSSF for Contribution Payment Method

National Social Security Fund (NSSF) - Notification No. 813/20 dated 30 September 2020 on NSSF contribution payments to authorized banking and financial institutions

The NSSF issued a notification on 30 September 2020 to inform the owners or directors of enterprises/ establishments that the NSSF has partnered with the following banks and financial institutions for the monthly contribution payments to the NSSF:

Construction – Application for a Certificate of Occupancy for Constructed Buildings

The Ministry of Land Management, Urban Planning and Construction (“MLMUPC”) – Notification No. 341 dated 25 September 2020 on the obtaining Certificate of Occupancy for constructions that are built before enforcement of Law on Construction. (“Notification”)

In accordance with the Law on Construction dated 2 November 2019, the MLMUPC has informed that any constructions including borey, condominium, commercial building, office building, industrial factory, warehouse, station, hotel, gas station, and etc., built before Law on Construction comes into effect and have been using without having a construction permit or built not in compliance with its construction permit and construction owner obtained a construction permit without having a permit for opening/closing the construction site built before 2 November 2019.

Therefore, the construction owner has the obligation to obtain the occupancy certificate in accordance with the Law on Construction and Prakas No. 177 before enforcement of Law on Construction. The owners of the constructions built before 20 December 1997 can also apply for the occupancy certificates from the competent authorities.

The issuance of the occupancy certificate is limited and applicable for the construction owner to apply within two (2) years after the Law on Construction comes into effect, starting from 2 November 2019 until 2 November 2021.
