### Amendment of Specific Tax (ST) Rates on Locally Produced Non-alcoholic Beverages

(Notification 28271 GDT, dated 15 August 2023)

Further to the promulgation of the new 2023 Law on Taxation (LoT) and Sub-Decree no. 122, dated 6 June 2023, this notification was issued by the General Department of Taxation (GDT) to inform all enterprises in the non-alcoholic beverage industry that produce and supply locally in Cambodia regarding the new ST rates effective from 1 September 2023 onwards:

- 1. 15% ST on all kinds of energy drinks
- 2. 5% ST on certain non-alcoholic beverages, including:
  - Milk-based drinks that undergo high ultraviolet (UV) radiation
  - Soy milk
  - Coconut water-based drinks
  - · Coffee-based drinks or drinks with coffee-added flavor
  - · Non-carbonated drinks for instant consumption
- 3. 10% ST on other non-alcoholic beverages not mentioned above

The calculation base of ST shall be implemented in accordance with the existing Prakas 012 MEF.Prk, dated 14 January 2020.

#### **Our comments**

This GDT notification informed the affected taxpayers on the ST rates imposed on local production and supply of specific non-alcoholic beverages which is in line with the provisions of the 2023 LoT and Sub-Decree no. 122. For instance, while the ST on energy drinks is increased by 5%, the ST on specific milk, coffee products, and non-carbonated drinks is also reduced by 5%. Affected taxpayers should review the product descriptions and be aware of the new ST rates to ensure proper compliance with this new notification.
