Important Notice on Income Tax Return Submission for the Year of Assessment 2023/2024

Please be informed that the last date for submitting all Income Tax Returns (CIT/IIT/PIT) for the Assessment Year 2023/2024 is Saturday, 30th November 2024. To facilitate timely submission, the Inland Revenue Department (IRD) will keep its Head Office and all Regional and Metro Offices open on that day as usual working day.

Please note that any income tax returns received after the due date (30th, November) regardless of submission method, will be subject to time bar provisions.

If you encounter difficulties in submitting your income tax return online, you may seek assistance at the following locations:

Inland Revenue Department Head Office:

Special Unit (Ground Floor)

Change Management Unit (12th Floor)

Central Documents Management Unit (1st Floor)

VIP Tax Unit (for taxpayers registered with the VIP unit)

High Wealth Individuals Unit (for taxpayers registered with the HWI unit)

All Regional and Metro Inland Revenue Offices

The IRD has received withholding tax / advance income tax data for the Assessment Year 2023/2024 from all banks and financial institutions. This information is being integrated into the RAMIS system. To avoid potential additional assessments, interest, and penalties, it is crucial to accurately update / enter all withholding tax/ advance income tax and related interest income details in your income tax return.

We urge all taxpayers to prioritize the timely and accurate submission of their income tax returns.
