In reference to our Tax Alert dated 19 December 2024, please note that on 31 January 2025, notifications were issued and subsequently uploaded on both the Department of Imports and Export Control website and the Ministry of Finance website. These notifications address the removal of restrictions on the importation of motor vehicles, including cars and vans for personal use, buses for public passenger transport, vehicles for goods transport, special purpose vehicles, trishaws, bicycles, and other non-motorized vehicles. The applicable taxes on these motor vehicles have also been updated accordingly.

Removal of Import Restriction on Motor Vehicles

1. Annexure 01 – Notification issued under Import and Export Control Act No 01 of 1969 on the Removal of Import Restriction on Motor Vehicles

This notification refers to Regulations cited as Imports and Exports (Control) Regulations No. 02 of 2025 and the Gazette Notification No 2421/44 dated 31 January 2025 relevant to the same is pending to be issued.

- Schedule A of this notification provides for the removal of the temporary import restrictions on vehicles listed under 304 HS Codes under Chapter 87.02 , 87.03, 87.04, 87.05, 87.11,87.12 and 87.16
- Schedule B of the notification provides for certain vehicles that require Special Import License for importation and are inserted into the Schedule I and Schedule V of the Special Import License Regulations No.01 of 2023.

2. Annexure 02 – Press release issued by the Ministry of Finance on removal of temporary suspension on importation of motor vehicles

The press release sets out the conditions to be followed at the point of importation of vehicles in view of encouraging revival of normal economic activities and safeguarding the economic stability of the country. The conditions set out seems to aim at protecting foreign exchange reserves , discouraging importation of an excessive number of vehicles and keeping unnecessary stocks of motor vehicles and increasing fiscal revenue.

Vehicles can be imported by

- Importers registered with the Department of Motor Traffic
- State Institutions
- Any other importer (other than importer referred above) is permitted to import only one vehicle within a 12 months period.

Removal of Import Restriction on Motor Vehicles – Conditions Stipulated by the Ministry of Finance

02

Registration within 90 days

Any imported motor vehicle should be registered with the Department of Motor Traffic in the name of the buyer (on instances when purchasing a motor vehicle from a registered importer) or in the name of importer within 90 days from the date of Bill of Entry/ Customs Declaration (CUSDEC).

03

Importer/Buyer to provide Affidavit

The importer or buyer shall submit an Affidavit including the Taxpayer Identification Number (TIN) along with other required documents to the Commissioner General of Department of Motor Traffic for the registration of motor vehicles (MV).

04

Monthly late Fee

Failure to register any imported motor vehicle within 90 days by an importer, will impose a monthly late fee of 03% of the CIF value up to maximum cap of 45 % CIF value, at the time of registration of motor vehicles at the Department of Motor Traffic. No waiver pertaining to the payment of monthly late fee would be granted under any circumstances.

05

No importation under MV import permit

Importation and Customs release of any motor vehicle using the motor vehicle import permits which have been issued with concessionary rates of duties will not be allowed.

If any MV is imported in violation of any prevailing Rules/Regulations , such MV(s) shall be re-exported by the respective importer within 90 days from the date of the Bill of entry/CUSDECC.

Imposition of Customs Duty and Surcharge on Customs Duty on Importation of Motor Vehicle

3. Annexure 03 - Customs Import Duty (CID) Imposition at the rate of 20% & surcharge of 50% of the CID rate

(a) Customs Duty

The Gazette Extraordinary Notification No. 2421/05 dated 27 January 2025 under the Revenue Protection Act, No. 19 of 1962 was published giving effect to re-impose the applicable Customs Import Duty (CID) at the rate of 20% w.e.f 28 January 2025 on importation of motor vehicles specified under the Chapter 87 of the HS Codes.

Revenue Protection Order No 1 of 2025 has been issued under the Revenue Protection Act No 19 of 1962 to remove the exemption imposed on *"Import of vehicles, chassis fitted with engines, bodies and cut portions, as defined in Chapter 87 where Excise (Special Provisions) duty under the Excise (Special Provisions) Act, No. 13 of 1989, is applicable."*

Accordingly, Custom Import Duty of 20% would apply on the importation of Chapter 87 motor vehicles.

Imposition of Customs Duty and Surcharge on Customs Duty on Importation of Motor Vehicle

(b) Surcharge on Customs Duty

The Surcharge of 50% of the CID rate has been imposed via Gazette Notification No2421/43 dated 31 January 2025 (under Section 10 (a) of the Customs Ordinance) effective from 01 February 2025 for a period of one year on identified HS Codes under heading 87.02, 87.03 and 87.04

(a) Gazette Notification No 2421/41 dated 31 January 2025 issued under the Finance Act No. 35 of 2018 – Revision of the threshold for the luxury tax on motor vehicles.



The Luxury Tax Free Threshold has been increased by LKR 1.5 million. However, the Luxury Tax rates for identified HS Codes remain unchanged. Additionally, there are no changes for HS Codes where the luxury tax free threshold was previously set at LKR 6 million.

REGULATIONS

1. These Regulations may be cited as the “**Imports and Exports (Control) Regulations No. 02 of 2025**”.
2. These Regulations are promulgated based on decision of the Cabinet of Ministers dated September 13, 2024 on the Memorandum No. 24/1945/604/208 dated September 12, 2024 titled, “Approval for removal of Temporary Suspension on Importation of Motor Vehicles”.
3. The Imports and Exports (Control) Regulations No. 02 of 2023, published in the Gazette Extraordinary No. 2312/78 dated January 01, 2023 as amended subsequently and as last amended by the Imports and Exports (Control) Regulations No. 01 of 2025, published in the Gazette Extraordinary No. 2421/04 dated January 27, 2025 is hereby further amended.
4. The Imports and Exports (Control) Regulations No. 01 of 2025, published in the Gazette Extraordinary No. 2421/04 dated January 27, 2025 is hereby rescinded without prejudice to the validity of any actions performed thereunder.

5. Goods, classified under the HS Codes together with their corresponding entries as described in the Schedule A below, which is an integral part of these Regulations, shall be deleted from the **Schedule I** of the Imports and Exports (Control) Regulations No. 02 of 2023, published in the Gazette Extraordinary No. 2312/78 dated January 01, 2023;

6.1 (i) An importer registered under the Department of Motor Traffic as a motor vehicle importer is permitted to import required number of motor vehicles classified under the HS Codes referred to in the Regulation No.5 above for trading purpose.

(ii) No importer other than an importer referred to in Regulation No. 6.1 (i) above, shall be permitted to import vehicle(s), classified under the HS Codes referred to in the Regulation No.5 above within a period of twelve (12) months from the date of Bill of Entry (Customs Declaration – CUSDEC) of the imported motor vehicle.

(iii) Notwithstanding the Regulation No. 6.1 (ii) above, Government organizations or development projects awarded by Government organizations or Diplomatic Missions in Sri Lanka are permitted to import required number of motor vehicles, classified under the HS Codes referred to in the Regulation No.5 above.

6.2 (i) An **importer** referred to in the Regulation 6.1 (i) above shall register such motor vehicle(s) in the name of buyer and other importers referred to in the Regulation No. 6.1 (ii) and (iii) above shall register such motor vehicle(s) in the name of the importer with the Department of Motor Traffic, within 90 days from the date of Bill of Entry (Customs Declaration - CUSDEC) of said motor vehicle(s).

- (ii) For the purpose of registration of motor vehicles, classified under the HS Codes referred to in the Regulation No.5 above, the importer or buyer shall submit an Affidavit affirming his or her Tax Payer Identification Number (TIN) issued by the Department of Inland Revenue, along with other required documents to the Commissioner General of Department of Motor Traffic.
- (iii) Director General of the Sri Lanka Customs shall ensure inclusion of this Gazette Notification Number and the Cost-Insurance-Freight (CIF) value of the relevant motor vehicle imported under the provisions of these Regulations, respectively in the Cage Nos. 44 and 46 of the Customs Declaration.

6.3 If an **importer** fails to register any motor vehicle(s), imported as per provisions of these Regulations within the 90 days as specified in the Regulations No. 6.2 (i) above, such importer shall be liable to pay a monthly late fee of 03% (Three percentage) of the Cost-Insurance-Freight (CIF) value of the said motor vehicle(s), which will be computed non-compounded linearly to the Commissioner General of the Department of Motor Traffic at the time of registration of motor vehicles, where a maximum cap on the payment of the monthly late fee for such late registration is limited at 45% (Forty-five percentage) of the CIF value of respective motor vehicle. For the purpose of this Regulation,

- (i) Commissioner General, Department of Motor Traffic shall register any motor vehicle(s), classified under the HS Codes referred to in the Regulation No.5 and imported as per the provisions of these Regulations beyond 90 days from the date of Customs Declaration under the prevailing rules and regulations subject to the payment of monthly late fee as specified above,
- (ii) **No** waiver of the payment of monthly late fee shall be granted under any circumstances and
- (iii) Any number of late days less than 30 days shall also be considered as a calendar month.

6.4 Any importer, who imported motor vehicles more than 25% of his or her total imported motor vehicles during a period of every six (06) months from the date of these Regulations until the end of February 2026 in violation of the provisions of the Regulation No.6.2(i) above, shall be suspended from importation of motor vehicles

for a minimum period of thirty six (36) months under the provisions of these Regulations.

7. The age of a motor vehicle for the purpose of these Regulations shall mean the period between the Date of Manufacture (Mentioned either in the Manufacturer's Certificate or Export Inspection Certificate, specified in the Imports and Exports (Control) Regulations, No. 02 of 2013, published in the Gazette Extraordinary No. 1804/17 dated April 03, 2013) and date of the Bill of Lading or Airway Bill of that motor vehicle.
8. Any motor vehicle, classified under the HS Codes referred to in the Regulation No.5 above, shall not be allowed for the importation and Customs clearance by the Director General of Customs under any Vehicle Import Permits, issued at concessionary rate of duties/taxes.
9. If any motor vehicle(s), specified in the Regulation No. 5 above, is imported in violation to these Regulations and/or any prevailing Rules and Regulations applicable on importation of motor vehicle(s), such motor vehicles(s) shall be re-exported by the respective importer within ninety (90) days from the date of the Bill of Entry (CUSDEC) with all associated costs borne by the said importer.
10. Licensed banks shall submit a daily report on Letter of Credits established for importation of motor vehicles under the provisions of these Regulations, to the Controller General of Imports and Exports.
11. The Special Import License Regulations No. 01 of 2023, published in the Gazette Extraordinary No. 2312/77 dated January 01, 2023, as subsequently amended, is hereby further amended.
 - 11.1 Regulation No.6 of the Special Import License Regulations No. 01 of 2023 referred above is hereby deleted without prejudice to the validity of any actions performed thereunder.

11.2 Goods described in the **Schedule B** below shall be inserted into the **Schedule I and Schedule V** of the Special Import License Regulations No.01 of 2023, referred above.

12. To achieve the objectives of these Regulations, the Controller General of Imports and Exports shall issue "Operational Instructions" to the Director General of Customs, licensed banks or any other relevant authorities.

13. The final decision shall be made by the Controller General of Imports and Exports on any issues arising in relation to these Regulations except the Regulation No. 9 above.

14. These Regulations shall enter into force with effect from February 01, 2025.

15. Interpretation;

15.1 Date of Manufacture shall mean;

Fifteenth (15th) of the relevant month specified either in the Manufacturer's Certificate or Export Inspection Certificate, specified in the Import and Export (Control) Regulation, No. 02 of 2013, published in the Gazette Extraordinary No. 1804/17 dated April 03, 2013.

15.2 In case, if the month of manufacture is not specified (only the year of manufacture is indicated) in the Manufacturer's Certificate or Export Inspection Certificate referred in 15.1 above, the Fifteenth (15th) of January of the year specified should be considered as the Date of Manufacture.

Removal of Temporary Suspension on Importation of Motor Vehicles Stage III

The Gazette Extraordinary Notification No. 2421/44 dated January 31, 2025 under the Imports and Exports (Control) Act, No. 1 of 1969 is promulgated with effect from February 1, 2025 allowing the importation of motor vehicles such as cars and vans for personal usage, buses for public passenger transport, vehicles being used for goods transport purposes, special purpose vehicles, trishaws, bicycles and other non- motorized items classified under a total of 304 HS Codes by lifting the temporary suspension of imports which has been in effect from early 2020.

Following conditions have been imposed pertaining to importation of vehicles in view of encouraging revival of normal economic activities and safeguarding the economic stability of the country , while taking into account protecting foreign exchange reserves, discouraging importation of an excessive number of vehicles and keeping unnecessary stocks of motor vehicles and increasing fiscal revenue.

- i. Required number of vehicles can be imported by the importers registered with the Department of Motor Traffic and State Institutions subject to the Regulations imposed by the said Gazette Notifications.
- ii. Any importer other than the importer referred in the (i) above is permitted to import only one (01) vehicle within a period of twelve (12) months.
- iii. Any imported motor vehicle shall be registered with the Department of Motor Traffic in the name of the buyer (on instances when purchasing a motor vehicle from a registered importer) or in the name of importer within ninety (90) days from the date of Bill of Entry/ Customs Declaration (CUSDEC).
- iv. The importer or buyer shall submit an Affidavit including the Tax Payer Identification Number (TIN) issued by the Department of Inland Revenue along with other required documents to the Commissioner General of Department of Motor Traffic for the registration of motor vehicles.

Further, importers, other than the importers referred in the (i) above, shall mention in the said Affidavit that they have not imported any other vehicle during a period of 12 months (from the date of the CUSDEC) after importing the first vehicle.

- v. If it is failed to register any imported motor vehicle within 90 days by an importer, such importer shall be liable to pay a monthly late fee of 03% of the Cost-Insurance-Freight (CIF) value up to maximum cap of 45 % CIF value, at the time of registration of motor vehicles at the Department of Motor Traffic.
- vi. No waiver pertaining to the payment of monthly late fee shall be granted under any circumstances.
- vii. When determining the age of the motor vehicle, the period between the Date of Manufacture and date of the Bill of Lading or Airway Bill of that motor vehicle shall be calculated.
- viii. It shall not be allowed for importation and Customs release of any motor vehicle using the motor vehicle import permits which have been issued with concessionary rates of duties.
- ix. If any motor vehicle is imported in violation of any prevailing Rules and Regulations, such motor vehicles (s) shall be re-exported by the respective importer within ninety (90) days from the date of the Bill of Entry/ CUSDEC.

The Gazette Extraordinary Notification No. 2421/05 dated January 27, 2025 under the Revenue Protection Act, No. 19 of 1962 was published giving effect to re-impose the applicable Customs Import Duty (CID) which had not been charged in terms of the provisions of the Customs Ordinance to exempt the duties. Accordingly, Customs Import Duty (CID) at the rate of 20% of CIF value was imposed effective from January 28, 2025 on importation of motor vehicles specified under the Chapter 87 of the HS Codes.

However, Gazette Extraordinary Notification No2421/43 dated January 31,2025 has been promulgated under Section 10 (a) of the Customs Ordinance in order to impose a surcharge on the Customs Import Duty in a manner that 30% of CIF value should be charged as the Customs Import Duty effective from February 01, 2025.

Accordingly, provisions have been made to charge a total Customs Import Duty of 30% on the importation of motor vehicles under the Customs Ordinance (Chapter 235) in the way that 20% of the currently applicable Customs Import Duty plus 50% Surcharge on it.

ORDER UNDER SECTION 10 A

By virtue of the powers vested in me under Section 10 A of the Customs Ordinance (Chapter 235) as amended by Act, No. 83 of 1988, I, Anura Kumara Dissanayake, Minister of Finance, Planning and Economic Development of the Democratic Socialist Republic of Sri Lanka, do by this order levy on imported goods specified in the Schedule hereto, a surcharge at the rate of 50% on applicable Customs Import Duty, both General and Preferential basis, with effect from February 01, 2025 for a period of one year.

PRESS RELEASE

Issuance of New Regulation and Order by the Minister of Finance, Planning, and Economic Development

The Hon. Minister of Finance, Planning, and Economic Development has issued the following Regulation and Order, which have been published in the Extraordinary Gazette Notification:

1. Regulation under the Finance Act, No. 35 of 2018

Gazette Notification No. 2421/41 dated January 31, 2025 issued to revise the threshold for the Luxury Tax on Motor Vehicles.

2. Order under the Excise (Special Provisions) Act, No. 13 of 1989

Gazette Notification No. 2421/42 dated January 31, 2025 issued to revise the Excise Duty on Electric Vehicles.

These revisions have been implemented as part of the government's ongoing efforts to streamline tax revenue, aiming to achieve a revenue target for 2025 by lifting the temporary restriction on motor vehicle importation, while maintaining the stability of external sector.

NOTIFICATION UNDER THE FINANCE ACT, No. 35 of 2018

Luxury Tax on Motor Vehicles

BY virtue of the powers vested in me by Section 19 read with Section 51 of the Finance Act, No. 35 of 2018, I, Anura Kumara Disanayake, Minister of Finance, Planning and Economic Development, do by this regulation amend the regulations published in *Extraordinary Gazette Notification No. 2147/72* dated October 31, 2019, as last amended by the *Extraordinary Gazette Notification No. 2312/69* dated December 31, 2022, by the substitution for Schedule I thereto with the schedule hereto, with effect from ~~01.02.2025~~.
