Introduction

Value-Added Tax (VAT) Refunds and Lottery Incentive

In this manual we have tried to help expatriates living in Mongolia with E-barimt registration and explain how to register receipts and claim a VAT refund. The e-barimt system supports only Mongolian language at the moment and therefore we have prepared the guide with screenshot pictures.

VAT applies to most purchases of goods within Mongolia and the rate is 10%. All businesses are obliged to use Point of Sale (PoS) systems in order to register their sales and each PoS is connected to the e-barimt network which creates a unique QR code on the receipt. End users and consumers who have subscribed to the E-barimt mobile application can scan the QR code and register their purchase instantly with the Mongolian Tax Authority (MTA). The consumers then receive in exchange up to 2% of the VAT 10% paid at the end of every quarter to their registered Mongolian bank account. This incentivizes end-users to demand receipts from retailers, service providers and merchandisers, and consequently pressures businesses to accurately declare their sales.

First, taxpayers should sign up on E-barimt.mn and register the receipts through the mobile application. Following personal information is required when sign-up:

- Surname and given name
- Taxpayer number
- Email address
- Mongolian phone number
- Mongolian bank account detail

Lottery

Taxpayers can win up to 30 million MNT from the receipts scanned in a previous month and the lottery runs at least once a month. The lottery number contains 2 letters followed by 8-digit numbers from AA00000000 to ZZ99999999. Your lottery result is available on your E-barimt account after every draw:

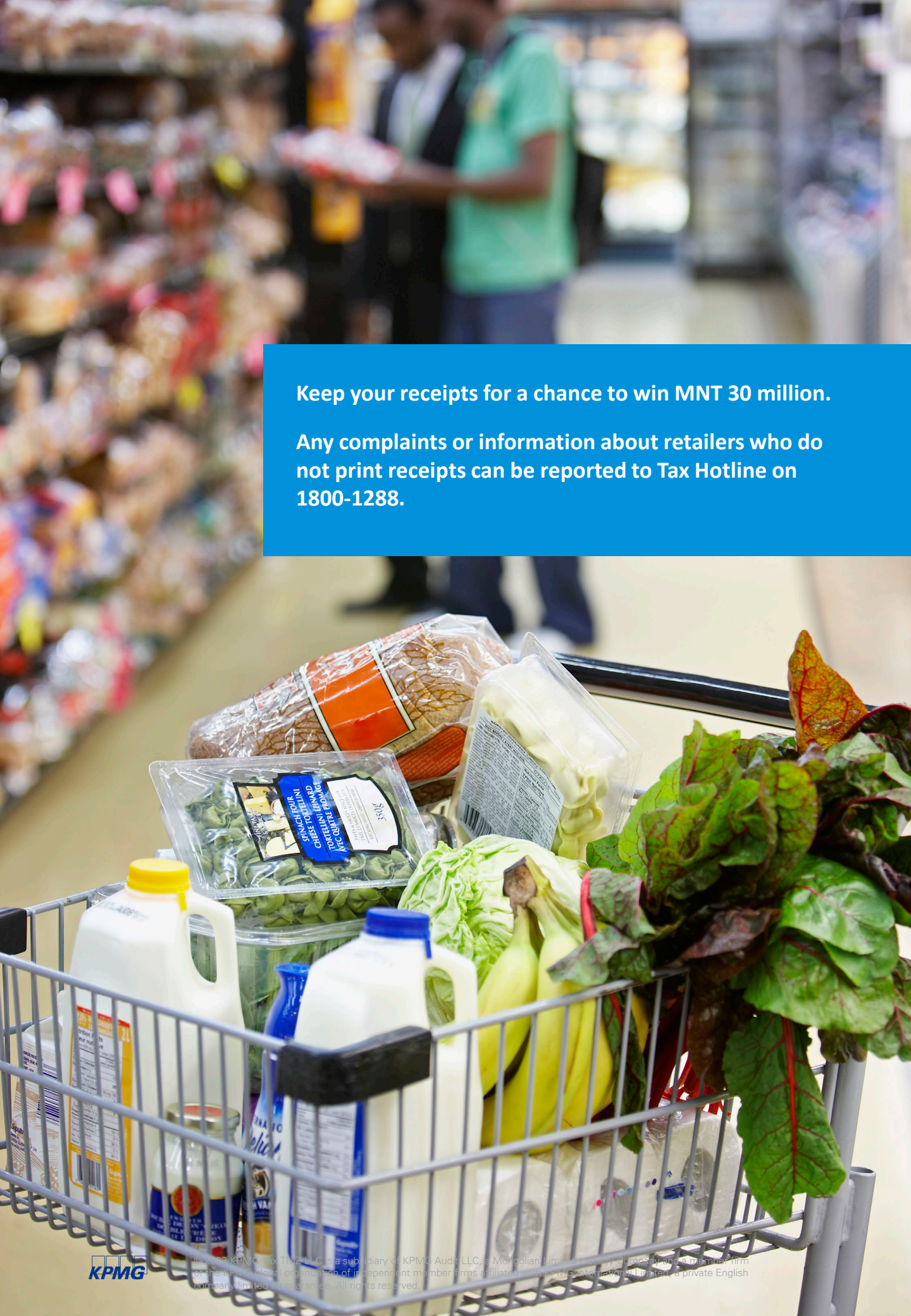


Note that some retailers provide electronic receipts by email. Also, it should be noted that the e-barimt system is poorly adapted to the small open-air markets popular in Mongolia

Prize-money payment is made directly to your nominated bank account. Prizes with large amounts are to be requested and claimed in person at the MTA.

Please note that certain type of services (such as medicals) is exempted from VAT and there will be no refund due. However, these vendors and merchants are still obliged to provide receipts with lottery numbers.

VAT refund and incentives are relieved from Personal income tax.



Keep your receipts for a chance to win MNT 30 million.

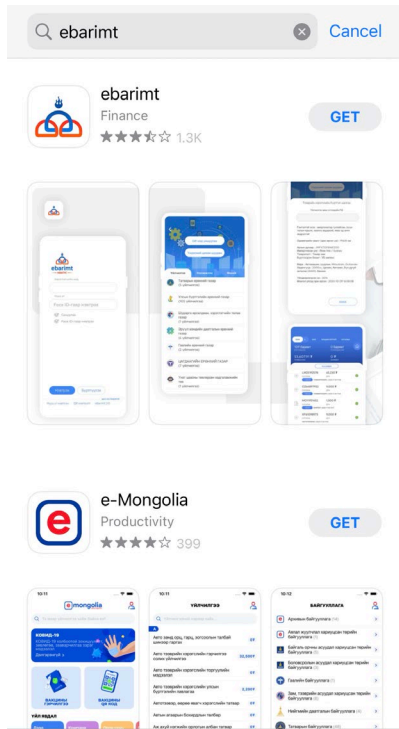

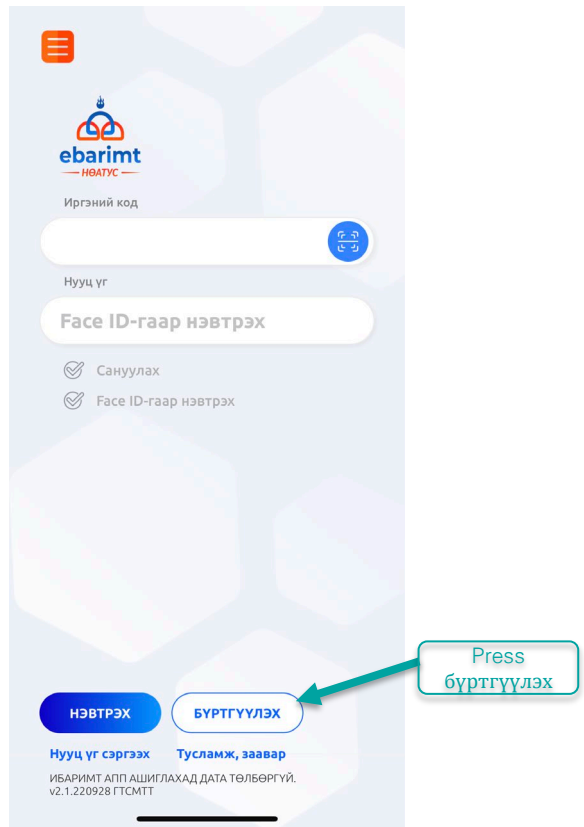
1. Launch an App Store / Google Play

- Install ebarimt application

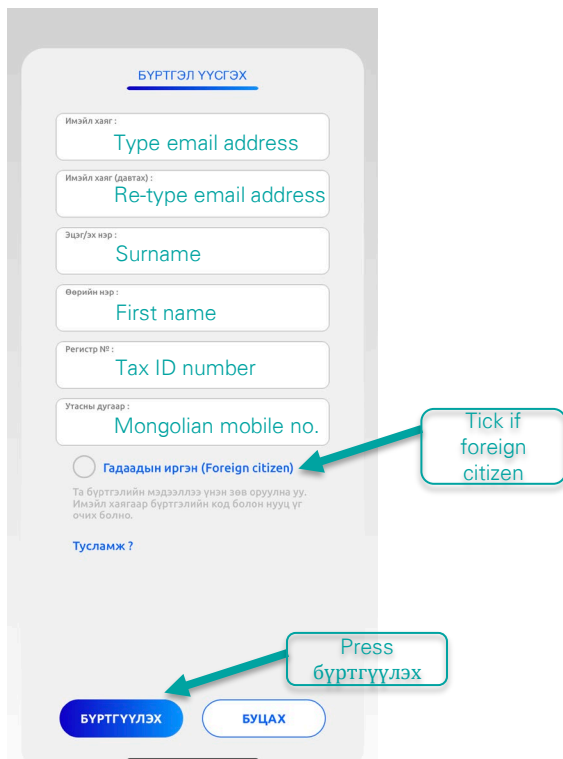


2. Sign-up for Ebarimt

- To register, please click Бүртгүүлэх

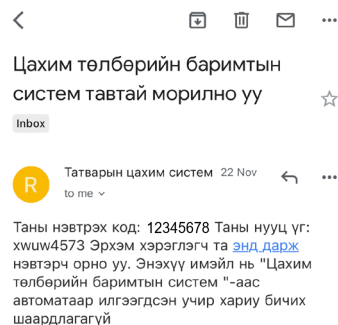

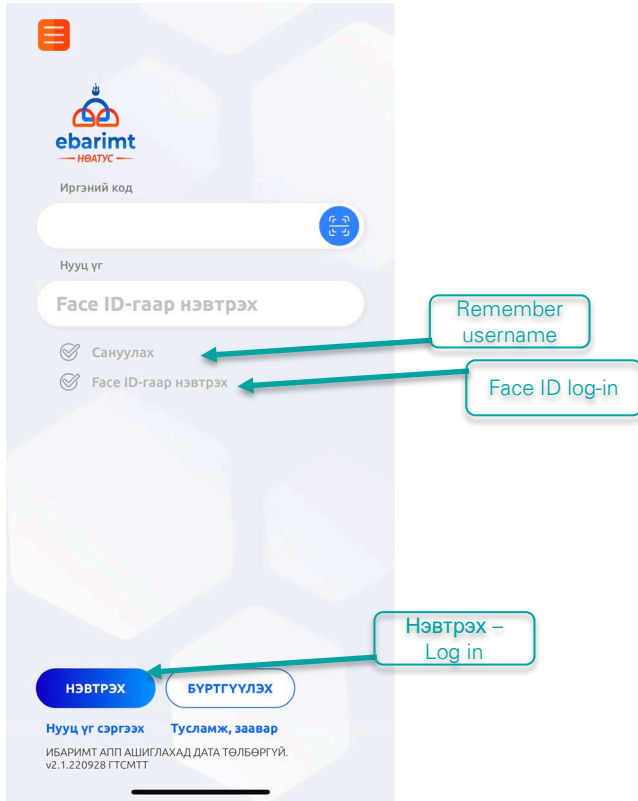

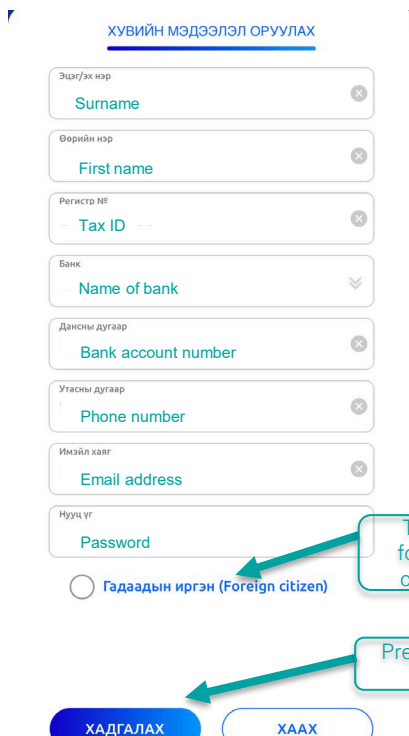

7. Setting-up bank account



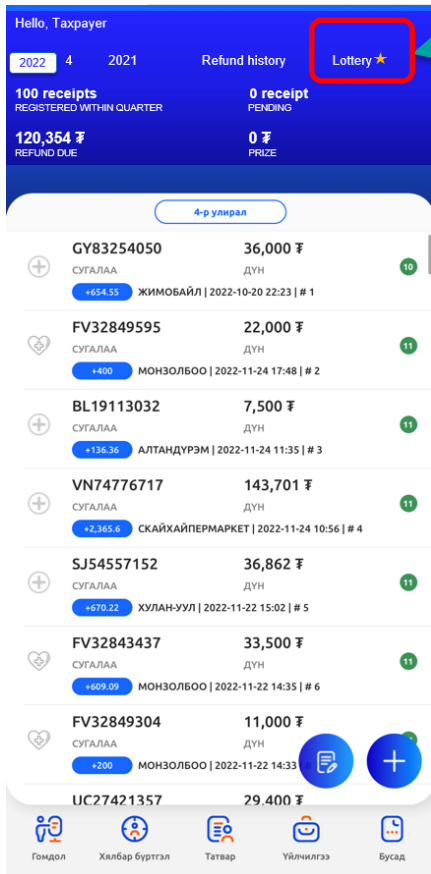
