



The e-Invoice will bring impact to Business-to-Business (B2B), Business-to-Consumer (B2C) and Business-to-Government (B2G) transactions. What is an e-Invoice?

- Digital representation of a transaction between a supplier and a buyer
- Replaces paper or electronic documents such as invoices, credit notes and debit notes
- File created in the formats specified by the Inland Revenue Board (IRB) that can be automatically processed by relevant systems: XML and JSON

e-Invoicing implementation timeline

- Mandatory enforcement of e-Invoice for taxpayers with annual turnover or revenue exceeding RM100 million by 1 August 2024
- Taxpayers with annual turnover or revenue between RM25 million and up to RM100 million to implement e-Invoice by 1 January 2025, while other income categories is to enforce e-Invoice by 1 July 2025



With the global push on tax administrations to increase efficiency and effectiveness, Malaysia is set to implement e-Invoicing in 2024.
