Updated Validations & Documentation	<ul style="list-style-type: none"> Updated Actual API deployed to Sandbox environment. Updated the UBL Sample XML and JSON for Foreign Currency and Multi-Line Item. Added a pagination URL parameter to the Get Submission. Included clarification on Tax Rate. Updated Shipping Recipient fields from “Mandatory where Applicable” to “Optional”. Updated SST Registration Number to a maximum character count of 35 and provided support for the special character – semicolon (;).
New Additions	<ul style="list-style-type: none"> Implement Minification of XML / JSON documents within the Submit Document API.
Other Updates	<ul style="list-style-type: none"> Updated the FAQ: <ul style="list-style-type: none"> Added guidance on QR code generation. Updated the title from Error 404 to Error 400 and replaced BadArgument with BadRequest. Updated TIN parameters.

New Additions	<ul style="list-style-type: none"> Added Signature Page and Relevant Samples for v1.1. Added Type Page and Relevant Samples for v1.1. Added new page (Sample) containing sample payload for each document type. Updated response to the Get All Document Types, Reject Document and Get Recent Documents APIs.
