Nneka’s radiant spirit transformed the ordinary into the extraordinary. Her smile and boisterous laughter were pure joy. She lived each day with an open heart, embracing life’s challenges with a vivacious and inspiring spirit.

Nneka joined our firm on the 6th of October 2003 and was admitted into the Partnership of KPMG Nigeria on 1 October 2017. Her outstanding professional career of over 20 years at KPMG is a powerful testament to her diligence, doggedness, dexterity and excellence in facilitating and steering strategic partnerships and supporting leading organisations to achieve their strategic goals across diverse regions in Sub-Saharan Africa, driving sustainable economic growth and creating lasting impact. Nneka rose to the esteemed position of Partner and Non-Executive Director of the KPMG West Africa Board.

She was a fellow of the Institute of Chartered Accountants of Nigeria (ICAN). Given her role as an Audit & Assurance Partner, Nneka brought to bear a unique blend of discipline, professionalism, brilliance and emotional intelligence that endeared her to her clients and colleagues across different walks of life. She had a track record of leading financial transformations and being at the forefront of humanitarian initiatives. She leveraged her experience to provide strategic contributions to various NGOs and mentoring several professionals.

Until her passing, Nneka enjoyed a stellar career at KPMG during which she was a key member of leadership overseeing the Financial Services Group and Audit Division. Nneka led complex audit engagements within the Financial Services Industry (FSI), including development banks, commercial and micro-finance banks, insurance companies, discount houses, finance companies, pension funds,



and asset management firms. Additionally, she was the People Partner for the Audit Division. In her role as People Partner, she oversaw people welfare, learning and development and several other strategic initiatives within the Audit Division. She was a role model, advocate, and champion of making the workplace an excellent environment for team members to thrive and prosper. It was in recognition of this drive, that she won several awards at KPMG. Some of the awards that were close to her heart included the KPMG Audit Division Head (ADH) Award which she won in 2016. This award recognises the most exceptional employee in the year and celebrates sustained outstanding performance, consistent dedication to excellence, and unrelenting commitment to raising the bar.





She was also proud of the “Promoting a Positive Environment” Award which she won in 2015 as it demonstrated her focus on establishing a positive workplace for her teams to excel.

During her remarkable career, Neka functioned as guest lecturer, speaker, panelist, chair and moderator at different professional and social events such as Audit Committee Seminars, Strategy Workshops and Training Programmes.

Neka was passionate about her personal development, and this inspired her to attend several courses and programmes which shaped her professionally. She obtained an Executive MBA from the prestigious Lagos Business School (LBS), a feat she achieved while managing several client demands. This is another testament of her doggedness and resilience as a professional. She attended the global Women of the Future Summit in the UK in 2015. In her words, this remained the best Women Leadership event that she attended in her career as she had the opportunity to network and learn from great women in positions of leadership globally. She always had a glint in her eye when she describes her experience of attending a quintessential British tea event at the Buckingham palace during that Summit. Neka will always say that she left the Summit being more resolute to actively contribute to creating an environment where talented women can flourish – key motivation for her passionate involvement in the KPMG Network of Women (KNOW). Neka led the KNOW Work-Life Harmony (WLH) working group focused on providing support for and enriching the experience of women in KPMG. Under her leadership, the WLH working group rolled out several initiatives to enhance the personal and professional growth of KPMG ladies. Neka also went ahead to attend other business and leadership courses run by reputable institutions such as the Harvard Business School Course in Strategy Execution.



In 2020, Nneka was invited by the LBS to be a member of the Curriculum Management and Learning Committee of the Institution. She accepted and functioned in this role with her usual high standard of dedication and excellence, as she made several value-adding recommendations on the Committee.

In addition to her role at LBS, Nneka was a member of the Board of Trustees (BoT) of the Oxbridge Tutorial College Legacy Foundation. In this role, she contributed to the efforts of the Foundation in mentoring and creating scholarship opportunities for meriting students who may not have the needed financial capacity to further their education.

She was involved in establishing a life skills academy short-term programme for young ladies as well as a key resource person at various workshop and skill empowerment programs for vulnerable women and girls from different backgrounds and walks of life.

Nneka will always be remembered as an Amazon at KPMG whose light was brilliant, colourful and endearing. She truly made her mark in no small measure, leaving a legacy that will always be admired and respected by all.

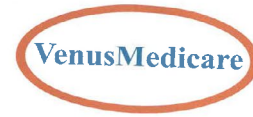
