REVIEW OF APPROVING AUTHORITY FOR EXPATRIATE QUOTA AND CITIZENSHIP APPLICATIONS

As part of the Ministry's ongoing commitment to enhancing transparency, accountability, and operational efficiency in the administration of Expatriate Quota and Citizenship applications, the Honourable Minister has approved a revised approval framework/guideline to address concerns related to potential abuses and irregularities within the system.
