NZ Budget 2019 - what does it means for the wellbeing of New Zealand?



New Zealand's first dedicated 'Wellbeing' Budget has been announced in May. This a budget that reflects the collective need, and desire, to address the inequalities that exist within our society. It moves beyond the traditional, narrow measures of success such as GDP and fiscal growth, to include success measures based around the four capitals of the Living Standards Framework – natural, social, human and financial, and physical. This is in addition to other success measures, such as child wellbeing and poverty indicators, and Statistics New Zealand's "Indicators Aotearoa New Zealand".

But what does the Wellbeing Budget mean for New Zealand business leaders?

We look into the four main areas that impact businesses – Infrastructure, Investment in innovation and skills, Money continuing to flow to the regions and an increase in economic activity.

Tax

Australia & NZ Subsidiaries - where are you resident?

In KPMG's latest TaxMail, we look at the Inland Revenue and Australian Taxation Office agreement for determining the tax residency of dual resident companies. Due to a change in our Dual Tax Agreement with Australia, introduced from 1 January 2019, New Zealand companies should be confirming their tax residency (and those of their Australian Subsidiaries) under both countries' rules and taking steps to manage the position. GST on imports & loss ring fencing Bill update

The Finance and Expenditure Select Committee have reported the Taxation Bill back to Parliament along with the release of the Officials Report. The Bill has three key items – GST on low-value imported items, loss ring fencing rules for rental properties, and changes to the Commissioner's Care and Management rules. With the report back earlier than expected, the Bill can be expected to become law by the end of June. Find out what this could mean for you in our TaxMail here.

Digital services: one-two punch?

The Government has released its previously announced Digital Services Tax ("DST") discussion document following the OECD's release of its updated work programme on tax issues arising from the digitalisation of the economy.

A DST would apply to electronic platforms facilitating the sale of goods and services (i.e. intermediation platforms), social media platforms, content sharing sites, and companies providing search engines or selling user data. This includes NZ businesses operating in this space (if they meet thresholds). Read our full update here.
