# Mandatory RUC Update for All Taxpayers by August 31, 2025

According to Resolution No. 201-4488 dated June 4, 2025, published in the Official Digital Gazette No. 30302 on June 17, 2025, the General Directorate of Revenue (DGI) mandates all individual and corporate taxpayers to update their Single Taxpayer Registry (RUC).

It is important to note that this Resolution provides a deadline of **August 31, 2025**, to complete the necessary updates. Failure to comply will result in fines imposed by the DGI.

In accordance with Article 290 of the Tax Procedure Code, formal infractions arise from non-compliance with formal obligations, including failing to update registry data within the established deadlines, with penalties ranging from one hundred balboas (B/. 100.00) to five hundred balboas (B/. 500.00).

All updates made through e-Tax 2.0 must be completed by filling in all mandatory fields as informed by the DGI in this resolution.
