Experience

Case 1

We were instructed by a major shareholder of a high end restaurant to assist in a shareholder dispute in Hong Kong. We assisted the client to quantify the valuation of the group (which is the subject of the dispute). We participated in the mediation process and provided expert witness support services in the Court.

Case 2

We were appointed as a single joint expert for a matrimonial divorce case in Hong Kong. Our expert provided both written evidence and oral testimony to the High Court of Hong Kong.

Case 3

Our client, a Hong Kong based company was awarded a favourable order for its claim damages arising from an improper termination of a contract by the opposing party by the arbitration court. KPMG assisted the client to quantify the losses as a result for the breach of the contract.

Case 4

A PRC based utility company filed an insurance claim to its insurer against its policy coverage on machinery breakdown and consequential loss. We were appointed by an insurance company to assist in the quantification of the loss sustained by a PRC company. We carried out a valuation of the agent's business and challenged the quantum of damages claimed. This led to a successful negotiated settlement for our client, which avoided a court appearance.
