Luxembourg, a competitive platform for shipping business

- The political willingness to diversify economy promotes a favorable infrastructure for industries that should be attracted (i.e. shipping industry)
- Rank 12/176 of the Corruption perceptions index (2012) by Transparency International
- Safety & Security ("The Safety & Security sub-index measures countries' performance in two areas: national security and personal safety"): Rank 7/142 (The 2012 LEGATUM PROSPERITY INDEX™ Rankings)
- Development of a jurisdiction of choice for maritime business and encouragement of the development of spinoff activities related to the maritime sector
- Maritime legislation created in 1990 by the Maritime Act
- History of registering / managing ships with sound existing processes, laws and regulations
- Several tax incentives such as accelerated depreciation of ships, investment tax credits and VAT exemption under conditions for supply, chartering and hiring of the seagoing vessel, no tonnage tax system

Luxembourg Maritime Sector at a glance:

Luxembourg has transposed all relevant European directives concerning maritime topics into national law.

Luxembourg Maritime Authority	A customer-minded one-stop shop ISO 9001 certified
Authorized activities	Buying and selling, chartering in and out or management of seagoing vessels
Eligibility for registration	Vessels less than 15 years of age, with possible exceptions granted by the Minister in charge Vessels of at least 25 tons
Ownership requirements	Ships must be more than 50% owned by EU nationals or by companies having their commercial seat within the EU
Total number	approx. 250 registered ships
Total Gross tonnage	approx. 2.3 million tons
Shipping companies	344 certified shipping companies 71 accredited maritime managers
Crewing	No nationality or residence requirements for the crew, except for the Captain who must be EU national Luxembourg allows the use of private armed guards
Well-known quality flag	International recognitions due to listing on several White Lists

- Lump sum taxation of 10% at most for non-resident seafarers working on board a vessel operated in international traffic
- Ship owners established in Luxembourg provide jobs to some 400 highly skilled employees on shore and around 4,000 at sea
- Simplified approval process for the deployment of armed guards in dangerous areas
- Broad recognition of foreign qualifications
- Strong financial service industry that can support the ship management industries
- Multilingual environment
