

## GUIDELINES

- 1 Each "inventory list" sheet must only contain import information from one project.
- 2 Simply add new sheets for inventory lists of other projects. Insert as many sheets as you have projects.
- 3 Expansions shall be construed as separate projects for the purpose of reporting the inventory list. (i.e., separate sheet)
- 2 Do not merge rows. Repeat enterprise names and project information per imported item.
- 3 Please follow the prescribed format for the TIN (i.e., 000-000-000-000)
- 4 Submit the report as an excel file. Do not protect sheets with passwords inaccessible to the BOC and the IPA.
- 5 As a guide in filling-out the template, sample data is provided
