

# Deadline for Filing Income Tax Return



## **Deadline for filing Income Tax Return and Payment of Income Tax**

Following the 2 months extension for filing of Income Tax Returns and payment of Income tax for the Taxpayers with 31 December 2019 year end, the tax filing deadline and tax payment deadline is **30 June 2020**. The deadline is fast approaching.

This is a kind reminder to all the Taxpayers with financial year ended 31 December 2019 to submit their Income Tax Returns and settle outstanding Income tax liability by the deadline.

The timelines and penalties are summarized below for your quick reference and action:.

<b>Financial year ended</b>	<b>31 December 2019</b>
<b>Due date for filing Income tax return and payment of income tax (extended deadline)</b>	<b>30 June 2020</b>
<b>Penalty for late filing of income tax return</b>	<b>QAR 500 per day (capped at QAR 180,000)</b>
<b>Penalty for late payment of income tax</b>	<b>2% of tax due per month or part thereof, up to the amount of tax due.</b>

Therefore, we recommend and urge all taxpayers to take timely actions to ensure that the income tax returns are filed on time to avoid unnecessary penalties.
