



Deadline by the GTA to correct
Dhareeba Transitional Issues –
on or before 14 January 2021



Tax Alert | 5 January 2021

The General Tax Authority (“the GTA”) has started sending emails and communications to taxpayers, asking them to review and update their account statements on “Dhareeba” before 14 January 2021.

In line with the notices, taxpayers are required to provide the GTA with proof of payments for each liability appearing as overdue on “Dhareeba” system, but which was actually already settled by the taxpayer. Taxpayers are also required to ensure that any **outstanding** penalties or additional taxes which were not settled before are either settled or otherwise necessary actions are taken (such as objections, appeals).

It is important to note that the GTA requested taxpayers to take the above necessary action before 14 January 2021. Failure to provide required evidence of payment within said deadline may lead to consider the “balances” listed on “Dhareeba” as effectively due for payment.
