Recent update - Arabic Financial Statements

Following our recent tax alert (captured in the trailing e-mail), please note that the General Tax Authority ('GTA') has reiterated on 3 June 2021 that Arabic Financial Statements (that are attached along with the Tax return) must be **audited and duly signed by both the Taxpayer and the Auditor**. This is as per Law No. 7 of 2019 related to Protection of the Arabic Language. Taxpayers are required to fully comply with this law.

KPMG would therefore like to remind Taxpayers of the obligation to submit **signed Audited Arabic Financial Statements** for the year 2020 Tax return filing.
