## Urgent Action Requested by the GTA Settlement of Outstanding Liabilities on Dhareeba

We are reaching out regarding the recent email communication from the General Tax Authority (GTA) concerning the settlement of outstanding liabilities on Dhareeba, and requesting Taxpayers to settle these liabilities on or before 29 August 2024.

We understand that you may need to respond to the tax authorities and may have questions regarding this process. Please do not hesitate to contact us should you need any assistance or if there are any concerns that need to be addressed.

It is worth highlighting that even for the Taxpayers who may not have received the recent communication from the GTA, we recommend taking the following steps to avoid any potential issues or surprises.

In this regard and to ensure that everything is managed accurately and efficiently, we recommend you take the following steps:

- **Review Your Dhareeba Account:** Please log into your Dhareeba account and verify if there are any outstanding amounts, including taxes and penalties, that require your immediate attention.
- **Examine the Reasons for Outstanding Amounts:** Investigate the reasons behind any taxes and penalties listed as outstanding in your Dhareeba account.
- **Address Unjustified Amounts:** If you identify any amounts that appear to be incorrect or unjustified, contact **us at [qa-fmtax@kpmg.com](mailto:qa-fmtax@kpmg.com)** or Dhareeba support Team at [support@dhareeba.qa](mailto:support@dhareeba.qa). Provide any necessary documentation / proof of payments to support your claim and seek corrections for these discrepancies.
- **Appeal and Objection:** For outstanding amounts resulting from ongoing Objections or Appeals, promptly inform the GTA or your KPMG Managers. Ensure that they are aware of the situation to facilitate timely resolution.
