## Tax Alert Issue 15: OECD released substantial documents on Amount A and STTR

On 11 October 2023, the Organisation for Economic Cooperation and Development (OECD) released the text of a new Multilateral Convention to Implement Amount A of Pillar One (MLC) that updates the international tax framework to co-ordinate a reallocation of tax rights to market jurisdictions, improve tax certainty and remove digital service taxes.

The MLC was accompanied by an Explanatory Statement, an Understanding on the Application of Certainty of Amount A and an Overview, together with a new analysis of the financial impacts of Amount A.

Previously on 3 October 2023, the OECD released a new Multilateral Convention to Facilitate the Implementation of the Pillar Two Subject to Tax Rule (STTR), which is open for signature to facilitate updates across the global network of bilateral tax treaties for STTR provisions.
