Developments for Long-Term Resident Visa in Thailand

Effective 1 September 2022, Thailand will be offering a new long-term resident or LTR visa to four categories of foreign nationals: wealthy global citizens, wealthy pensioners, work-from-Thailand professionals, and highly skilled professionals. Spouses and dependents of LTR visa holders will also qualify for the same visa.
