2020 overview and 2021 outlook

The global agenda was struck with the COVID-19 pandemic that broke out in China in December 2019 and spread globally in the spring as it was declared a pandemic by WHO. The unprecedented pandemic had an unusual impact on the life as we knew it and became a dominant topic of debate as it had effects on the economic agenda, business world and social life.

In addition to lockdown measures that came with the COVID-19 pandemic, the global agenda was also clouded by the muchdebated US elections, civil protests in the US and Hong Kong, armed conflict in the region of Western Asia and the UK's exit from the European Union.

As pointed out in our Report which encapsulates the general outlook of Global M&A activity, the global M&A volume had declined compared to the prior year with USD 3.6 trillion in 2020 considering the uncertainties due to the COVID-19 pandemic and the political turbulence in both developed and developing economies.

If we are to mention Turkey, in addition to the global issues regarding the pandemic, Turkey's agenda also led to limit the investor appetite and transaction volume. Concerns about economic growth in an ongoing pandemic world, conflict with the EU and neighboring countries fueled by natural gas exploration projects in the East Mediterranean, potential conflicts with the US, exchange rate volatility and security problems in the close geography were the key events 2020. In 2020, we see that the volume of M&A activity in Turkey has recovered from the lowest level of the last fifteen years and reached to 6.9 billion USD. The most determining factor to this increase from 2019 was the occurrence of mega deals (the acquisition of Turkcell by the Turkey Wealth Fund and the acquisition of Peak Games by Zynga), which are defined as transactions with volumes exceeding USD 1 Billion. When we examine the number of transactions, we observe that the level in 2019 was exceeded and additionally, the average volume per transaction increased compared to the previous year.

If we are to elaborate on the largest transactions of 2020, the acquisition of Turkcell's 26.2% shares by the Turkey Wealth Fund ("TWF") (USD 1800.6 million), the acquisition of Peak Games by Zynga (USD 1800.0 million), the acquisition of the public insurance companies by TWF (USD 953.5 million), the acquisition of Total Oil and Milan Petrol by OYAK (USD 450.0 million), and the transfer of the operating rights of the Çukurova Airport (USD 354.3 million) to joint venture of Favori İşletmecilik & Yako Tekstil stand out to be the leading transactions which accounted for approximately 78% of the total transaction volume realized in 2020.

The breakdown of transactions by the origin of investors in 2020 has changed from the previous year considering the transactions realized by the Turkey Wealth Fund. It is seen that, unlike previous years, domestic investors stand out in terms of both transaction volume and number of transactions.

When we analyze the sectoral breakdown of Turkey's M&A transactions in 2020, technology, media and communications (TMT), financial services and energy markets seem to emerge as leading sectors in terms of transaction volume.

Looking at the number of transactions; technology, media and telecommunication (TMT) sector stands out as it was in the previous years.

As we constitute our anticipation for 2021, the impact of the pandemic is expected to gradually decrease as a result of the vaccination studies, the unprecedented economic support and incentives provided by governments, the expansionary monetary policies of central banks and the provision of high liquidity packages, together with the highlighting of Turkey's capacity in the industrial sector leading to growth, employment and price stability to achieve monetary goals and exchange rate policy improvement, can be seen as the factors that stand out and could boost investor appetite throughout the stabilization process.

On the other hand, increasing effects of the COVID-19 pandemic, a prolonged recovery period, possible US and EU sanctions on Turkey, political uncertainty and security problems in the close geography of Turkey can be considered as downside risks.

Although investor appetite and risk perception are decisive factors for M&A activity, foreign investors' rationale has been redirected into certain strategic sectors in Turkey as we saw throughout 2020.

Along with the rapid implementation of the necessary reforms by the public and private sectors working together in Turkey, the upcoming period is expected to become significant and increase the volume of transactions in terms of foreign investments. In addition to the above, the investments to be made by the TWF in petrochemical, mining and energy projects from domestic resources, the sale process of the companies transferred to the Savings Deposit Insurance Fund ('' SDIF '') and the assets in the portfolio of the Privatization Administration ("PA") are among the factors that may increase the transaction volume.

Additionally, horse racing and betting private management contract process by TWF will be among the remarkable transactions that will take place in 2021 although it is not considered as a standard M&A transaction. In addition, we think that industrial production and automotive, technology, media and telecommunication, pharmaceutical and healthcare sectors will be among the prominent sectors in 2021.


With the acceleration of the global vaccination efforts and the end of the pandemic, we maintain our optimistic expectations for 2021 and anticipate that the number and volume of transactions will increase with the gradual improvement.




Global M&A Trends

Overview of transactions

Breakdown of global transaction volume by regions - 2020

- Looking at the global outlook of M&A transactions it is observed that the total transaction volume decreased to a certain extent and in comparison to 2019, total transaction volume reduced by USD 200 billion, resulting as USD 3.6 trillion. On the other hand, total number of transactions also decreased to 47,114, stopping its growth pace in line with the previous years.
- The reason of the decrease in M&A transaction volume globally stemmed from the decline in North America region which is by 21.3% in volume respectively mainly due to pandemic, trade wars and related reasons.
- In spite of the decrease in the average volume of transactions, more transactions with value exceeding USD 10 billion (which are classified as mega deals on global scale) took place compared to previous years, although total mega transaction volume in 2020 reduced by 4%.

Ratio of global transaction volume to global Gross Domestic Product (GDP) was 4.1% in 2020, while it is 4.5% for G20 countries.

- In 2020, total M&A transaction volume in G20 countries was USD 3.1 trillion and this corresponded to 85.4% of the total transaction volume globally.
- Turkey lagged behind G20 average with its transaction volume/GDP ratio below 4.5% and performed well below its potential in 2020. Due to this fact, we anticipate a significant growth in the transaction volume for the next years.

M&A Trends in Turkey

Overview of transactions

- In 2020, total number of transactions increased compared to 2019, also total disclosed transaction volume increased significantly to USD 6.9 billion. Based on our assessment of the volume of undisclosed transactions, total transaction volume is estimated to be approximately USD 9 billion.
- The ratio of GDP to total volume of disclosed transactions increased to 0.9% when compared to 2019 but it is still significantly below the global average.
- One other important issue regarding M&A transactions in Turkey is the fact that there were two "Mega Transactions", which are defined as transactions with a value above a billion-dollars in 2020.
- Covid 19, which started during late 2019, commenced and affected Turkey since March 2020, also affected the economic activity impacting negatively in the M&A transaction environment. Especially, many transactions expected to take place between March and May were inconclusive or postponed. With the precautions taken and the decreasing effect of Covid 19 first wave, there was an increase in M&A transactions in parallel with the gradual improvement in economic activity since June.
- Covid 19 has revealed that supply chains are dependent on a single production focus and pose great risks to the whole world due to natural disasters such as pandemic. Therefore, we think that it will be inevitable for countries and multinational companies to consider additional new investments in China and the Far East in order to diversify the rings in their supply chains. At this point, with the production infrastructure and capability, geopolitically holding a good position and having a well-trained labor force would be advantageous for Turkey and we anticipate a positive reflection in this regard to the forthcoming period in M&A transactions.








M&A transactions in Turkey (disclosed transaction volume)

Largest transaction

The biggest transaction in 2020 was TWF's acquisition of 26.2% of Turkcell shares for USD 1.8 billion. TWF thus became Turkcell's largest shareholder.


In addition, within the scope of the transaction, Finland-based Telia exited from Turkcell by selling all of its indirect shares of 24.02%, while the Luxem-bourg-based LetterOne private equity fund increased its share in Turkcell to 24.8% and became the largest minority shareholder.

Weight of Top 10 transactions in total transaction volume 91.7%



Significant deals in the sectors



- In 2020, with the increasing importance of digitalization in parallel with global trends, TMT sector stands out in terms of both the number of transactions and the transaction volume.
- Although there is no significant change in the number of transactions in the TMT sector, transaction volumes have increased significantly due to the number of transactions with a value above a billion-dollar compared to the previous year.
- The restrictive effects of the Covid 19 pandemic on social life have distanced investors from the traditional consumer market and lost significant momentum when both the number of transactions and transaction volumes were considered.
- Although there is no significant change in transaction volumes in life sciences sector, the number of transactions has increased.





Breakdown of transactions by origin of investors

- In 2020, the transaction volume of USD 3.8 billion realized by domestic investors exceeded the total transaction volume realized by foreign investors.
- In 2020, the number of M&A transactions realized by foreign investors was 32% of the total number of transactions. Foreign investors have the largest share of the total transaction volume in 2020, reaching a total transaction volume of USD 3.1 billion.
- In 2020, the transaction volume originated from foreign investors, which was USD 2.2 billion in 2019, increased by 40% and that 6 of the top 10 transactions were carried out by foreign investors.
- In 2020, US (18 transactions), UK (10 transactions), Germany (9 transactions), France (6 transactions) and Qatar (6 transactions) were among the countries with the highest number of transactions. In terms of disclosed transaction volumes US and Qatar were the leading countries.

- In 2020, the transaction realized by US based investors was the acquisition of 100% stake in Peak Games with a transaction value of USD 1.8 billion by Zynga. Also, the acquisition of 80% stake in Rollic Games with a transaction value of USD 168 million by Zynga was one of the largest transactions.
- Qatar's largest transaction was the acquisition of 10% of Borsa Istanbul by Qatar Investment Authority with a transaction value of USD 200 million. Qatar Investment Authority also acquired 42% of Istinye Park, one of Turkey's largest shopping centers, with an undisclosed transaction value. Qatar based QTerminals, acquired the operating rights of Akdeniz Port Operations from Global Investment Holding with a transaction value of USD 140 million.







Transactions by financial investors

- Financial investors (private equity, venture capital and sovereign wealth funds) were involved in 78 transactions in 2019, with a share of 3% in the total transaction volume. In 2020, financial investors were involved in 129 transactions, accounted for 52% of total transaction volume, which is significantly above the previous year.
- In 2020, the technology, media and telecommunications ("TMT") sector stands out in terms of the number of transactions, with a total of 93 transactions realized by financial investors. In disclosed transactions in 2020, it is observed that 64% of the total transactions carried out by the financial investors, with a transaction volume of 2.3 billion USD, are also in the TMT sector. This trend was similar in the past year both in terms of number of transactions and volume, in 2019, a total of 61 transactions were made in the TMT sector and these transactions constituted 65% of the total financial investor transactions on a volume basis.
- The largest financial investor transaction was TWF's acquisition of 26.2% of Turkcell's shares in June 2020 for USD 1.8 billion. This acquisition is followed by the following transactions; The merger of 6 public insurance companies by TWF for a total of USD 953.5 million, LetterOne's acquisition of 11.6% Turkcell shares for USD 333.6 million, and Qatar Investment Authority's acquisition of 10% stake in Borsa İstanbul for a consideration of USD 200 million.
- Another important financial investor transaction was the investment made by Actera in July 2020 in the multi-channel furniture and decoration products platform Vivense.
- The acquisition of 70% of Sesa Ambalaj by Öncü Girişim, which is the venture capital arm of Doğan Holding, for a consideration of USD 65.3 million is the largest transaction in the Industrial Production and Automotive sector by financial investor transactions.
- Among the significant financial investor transactions of 2020 are Mediterra's payment systems infrastructure provider Paycore's acquisition of 75.93% of its shares in October 2020 and acquisition of Pidem and Dürümle companies operating in the food retail sector in December 2020. Similarly, the sale of Doğanay Gıda's majority shares to Taxim Capital also drew attention among the important financial investor transactions in 2020, even though the value was not disclosed.

Number of transactions



Significant financial investor exits:

- The largest disclosed financial investor exit in 2020 was the sale of Vansan, manufacturer of pump and pump systems, to Japanese equipment producer Ebara for USD 108 million by Turkven in December 2020.
- Mediterra sold its majority stake in Mobiliz to GPS Bulgaria in March 2020
- Kuwait based NBK Capital exited its 50% majority stake in Bavet İlaç by selling its shares to the founding shareholders of the company in December 2020. NBK Capital was invested in the company in 2012.
- Similarly, Bancroft exited its investment in Kayalar Kimya by selling its shares to the founding shareholders, Kayalar Family, in October 2020. Bancroft was invested in the company in 2010.

Significant venture capital transactions:

- The US Silicon Valley-based venture capital Crankstart invested USD 25 million in Getir, another fast-growing venture of Nazım Salur, the founder of BiTaksi. In addition, some Brazilian and Turkish individual investors in Crankstart have provided an additional investment of USD 13 million. As a result, Getir completed the Series A investment round in January 2020 with a total investment of USD 38 million. Furthermore, Finberg, which operates as the venture capital of Fibabanka, became a shareholder of Getir with an undisclosed transaction value in September.
- Venture capitals Sequoia Capital and Endeavor's Catalyst, led by Riverwood Capital, made a total investment of USD 32 million to Turkey's most important technology initiatives Insider, completing its Series C investment round in June 2020.
- Meditopia, a meditation app, sold 25% of its shares to Vela Partners, Atlantic Labs and a consortium of individual investors for USD 15 million in June 2020.

Value creation in the public sector

As we mentioned in our report last year, there was dynamism in public sector transactions through privatization processes and SDIF transactions in 2018 and before. Since 2019, with the introduction of New Economy Program, it is aimed to create value in the public through the active role of TWF within the scope of economic transformation based on production, export and financial stability. TWF has realized this role with prominent transactions in 2020 and it continued to create value in the public sector with strategic and large-scale acquisitions.

As part of its goal to support Turkey's competitive companies, TWF acquired 26.2% shares of Turkcell, making itself the largest shareholder; thus increasing the savings of the national economy. In addition, the merging of public insurance companies under TWF's roof was another significant public sector transaction that also encouraged the growth of non-banking financial services.

Acquisition of the operating rights of Çukurova Airport by the joint venture of Favori İşletmecilik - Yako Tekstil and Qatar Investment Authority's acquisition of 10% shares of Borsa Istanbul from TWF stand out as this year's important public transaction. After the transaction, TWF will continue to be the largest shareholder in Borsa Istanbul with a share of 80.6%.

In 2021, private management contract process for horse racing and betting operations may be among the prominent transactions to be realized in the first quarter of 2021. Potential TWF investments in petrochemical, mining and power generation projects using domestic sources will be the main target projects to be announced in the upcoming years.

In addition to the transactions to be carried out by the TWF, the resettlement of the companies transferred to the SDIF in the post-pandemic era with economic stabilization and the resettlement of the assets in the ÖİB portfolio will be the potential factors that can increase the transaction volume in the public sector.

Turkish companies turn onto outbound mergers and acquisitions in order to attain "know-how," diversify their product line, reach to export markets and gain competitive advantage on global scale.

- Real estate transactions that do not generate operational income and cash flows are not considered.
- In determining the value of the transaction, purchase prices announced to the public are taken into consideration.
- In the sector classification of the target companies subject to the transaction, the sector classification of KPMG Global has been taken into consideration and some subsectors have been evaluated under the main sectors.
- In the calculation of the transaction volume / GDP, the disclosed GDP amounts for 2019 and the announced transaction volumes compiled in 2020 were taken into consideration. The same methodology was applied for the previous years.
