Özge İlhan KPMG Turkey M&A Advisory, Director oilhan@kpmg.com Welcome to the annual edition of the Turkish Startup Investments Review with the collaboration of KPMG Turkey M&A and the 212 teams.

This report aims to highlight 2021's key trends, opportunities, and challenges facing the venture capital market globally and in Turkey.

Following the increase in vaccination, 2021 was a year when the risks and uncertainties brought by the pandemic began to fade. In light of these promising developments and increasing significance of technology, the entrepreneurial ecosystem gained momentum and ended 2021 with a yearly record-high deal volume and number of deals. The total Turkish startup investment volume reached \$1.4bn with 252 investments and set an all-time record for the Turkish startup ecosystem. Including the acquisitions, the total deal volume of the startup ecosystem reached \$3.8bn in 2021.

One of the main pillars of such a successful year is the abundance of seed investments, totaling more than 220 deals and constituting more than 85% of the total number of deals. Previous years' seed investments provided a healthy growth path for many startups which are maturing and becoming the pioneers of the Turkish startup ecosystem. This is evident in the deal volume of Early VC Stage investments, which surpassed \$400M in 2021, more than ten times its size in 2020. It can be predicted such encouraging developments will further continue in 2022, especially in prominent sectors such as delivery & logistics, SaaS, gaming, fintech and ecommerce.

The startup ecosystem corresponds to approximately 0.6% of Turkey's 2021 GDP, which doubled its share compared to 2020.

#### Main highlights in Turkey's startup ecosystem in 2021

Global startup ecosystem reached an all-time peak in 2021 as in deal volume, more than doubling year on year. The record funding levels continued in 2021 with \$643.0bn invested globally, outperforming the previous set in 2020, \$335.0bn In 2021, an all-time annual growth record was achieved with a rate of 92%.

Turkish startup investments reached unprecedented levels in terms of deal amount and total deal volume. Compared to 2020, the total number of deals reached 252 in 2021 from 155 in 2020. Total deal volume was nearly 10 times larger in 2021 as it peaked at \$1.4bn in comparison to \$143M in 2020.

Startup acquisitions corresponded for over 63% of the total deal volume of the Turkish startup ecosystem for 2021, with a volume of \$2,430M. The acquisition volume peaked due to Trendyol's acquisition and Hepsiburada's IPO.

Ecommerce enabler, Delivery & Logistics, Gaming and SaaS were the verticals that attracted the most investments by deal volume, respectively. In terms of number of deals, throughout the year, Gaming led the way, followed by SaaS, Fintech and Marketplace. Turkish gaming industry continued to grow and remained the most sought-after vertical among investors. Three of the top ten deals were made in the gaming vertical while four were made in delivery & logistics.

The deal with the highest funding belongs to Trendyol as its minority stake was acquired by Softbank, General Atlantic, Princeville Capital, ADQ, Qatar Investment Authority, Chimera Investments for \$1.4bn with a valuation of \$16.5bn. Trendyol became the first-ever Turkish startup to exceed \$10bn valuation and become a decacorn.

Getir received 4 investments from a variety of investors and received a total funding of \$1,018M. This helped Getir's global expansion as the company is constantly looking for organic and inorganic growth paths. Getir expanded its international operations to the US and nearly every country in Europe.

Hepsiburada became the first Turkish company to go public in NASDAQ. The ecommerce enabler company received funding of \$761M from IPO investors at a valuation of nearly \$4bn.

Dream Games received two investments totaling \$205M, which brought its valuation to nearly \$1bn. In case of further funding in 2022, Dream Games will be the fastest Turkish startup to become a unicorn.



#### Significant deals in the sectors




- For 2021 fiscal year, the gaming industry had the highest number of deals with 51, followed by 28 deals in Software as a Service (SaaS), 23 deals in Fintech and 17 deals in Marketplace verticals.
- A Gaming company, Ruby Games, received an investment of \$10M from Turkish company Rollic Games in exchange for 20% stake.
- A SaaS company, Prota's
  100% shares, were
  acquired by French-based
  industrials company,
  Arkance SAS for \$30M.

- A Fintech company, Colendi, received an investment of \$12M from Turkey-based financial investor Re-Pie.
- A Marketplace company, Servislet, received an investment of \$12M from US-based Ethos Asset Management and UK-based Attributed Holdings.

# Breakdown of startup deals by origin of the investors


**Deal volume (USD million)**

- Seed Stage investments dominated the ecosystem by number of deals with 229 deals in 2021. On the other hand, as Turkish startups scaled and achieved higher valuations, acquisitions had the largest share in deal volume, with a total volume of \$2,430M in 2021.
- Volume of Later VC stage deals resulted as \$890M. All Later VC Stage deals were investments to Getir.
- In general, number of deals and deal volume across all investment stages recorded significant growth from their respective levels in 2020:
  - 2021, number of seed stage deals significantly increased in 2021, reaching 229 deals from 135 in 2020. Likewise, Seed Stage deal volume grew from \$67M in 2020 to \$91M in 2021.
  - Number of Early VC Stage deals increased to 20 in 2021 from 17 in 2020. Early VC Stage deal volume skyrocketed from \$34M in 2020 to \$421M, increasing by more than 12 times. It can be said that an average Early VC Stage deal size in 2021 is 10 times larger than an average Early VC Stage deal in 2020.
  - Number of Later VC Stage deals stayed the same at 3 deals. Later VC Stage deal volume also recorded a sharp increase from \$42M to \$890M, meaning that an average Later VC Stage deal in 2021 is 20 times larger in size than an average Later VC Stage deal in 2020.
  - Number of acquisitions increased by 18 from 27 in 2020 to 45 in 2021. Acquisition deal volume rose by \$240M from 2020.



#### Breakdown of startup deals by quarters



- The number of deals in 2021 was 252, nearly 100 more compared to 2020. Total deal volume surpassed \$1.4bn in 2021, which is approximately ten times of the size in 2020. In quarterly terms, the total deal volume peaked at \$733M in Q2 2021.
- Total deal number in Q4 2021 was 67, which is 28 more than the deal number for the same period in 2020. Deal volume for the same period more than tripled in Q4 2021 and reached to \$64.1M, compared to \$20.9M in Q4 2020.
- Rising number of deals and deal volume are a major indicator of how the Turkish Startup Ecosystem is expanding in a healthy way and paving the way more success in the upcoming years.
- Getir's four deals in FY2021 constitutes for over 70% of the total deal volume. While Dream Games obtained 15% share of the total deal volume with two deals, the rest of the 246 deals accounted for nearly 13% of the total deal volume.
- For comparison purposes, only Seed Stage, Early VC Stage, and Later VC Stage deals are exhibited in the above graph, excluding startup acquisitions.

- In 2021, Delivery & Logistics, Healthtech and Blockchain were the most prominent verticals constituting the outbound & diaspora deals.
- Ava Labs, a US-based blockchain company cofounded by Emin Gün Sirer sold company tokens through Initial Coin Offering (ICO). Proceeds mounted to \$230M. This is the first-ever ICO led by a Turkish company.
- BillionToOne, a USA-based healthtech company cofounded by Oğuzhan Atay received a \$55M investment. The company provides prenatal genetic testing for every expecting mother.
- Spain-based delivery & logistics company, Blok was acquired by Getir for \$10M, as a result of Getir's expansion strategy.
- Carbon Health, is a USA-based healthtech company received \$350M Later VC Stage investment from various investors including Lux Capital, Dragoneer Investment Group, Silver Lake (previous table).
