#### **Foreword**

Welcome to the annual edition of the Turkish Startup Investments Review with the collaboration of KPMG Turkey M&A and the 212 teams.

This report aims to highlight 2023's key trends, opportunities, and challenges facing the venture capital market globally and in Turkey.

Both global VC funding and the total number of deals has experienced a decline in 2023 while the total funding decreased from \$531.4 billion to \$344 billion and the number of deals plummeted from 51,894 to 37,808. The worldwide deal volume, as well as the number of deals decreased to the lowest points since 2019. The downturn in startup activity can be ascribed to a thematic context encompassing geopolitical tensions, macroeconomic uncertainties, and various challenges such as conflicts in Ukraine and the Middle East, elevated interest rates and inflation, a challenging environment for exits, and persisting concerns regarding startup valuations. Together, these factors contributed significantly to a decrease in investor appetite and led to a more cautious approach, resulting in more limited deal activity.

In 2023, the Turkish startup ecosystem saw a rise in the number of deals, totalling 297, which contrasts with the global startup trends. However, global trends were more pronounced in terms of deal volume, reaching a total of \$497 million, including startup acquisitions. The destructive earthquakes that occurred in Turkey on February 6, along with the uncertainty created by the election atmosphere, have had an impact on the startup ecosystem, exacerbated by global challenges such as access to finance and high inflation rates. However, despite a decrease in deal volume, the Turkish startup ecosystem demonstrated its resilience and vitality through an increase in the number of deals.

### Main highlights in Turkey's startup ecosystem in 2023

The global startup ecosystem demonstrated signs of slowing down in 2023 as both deal volume and count saw historic low levels. The deal volume, with c. 35% YoY decline, amounted to \$344 billion. There occurred a similar trend in the deal count as it amounted to 37,808 with c. 27% decline. In 2023, the startup landscape was mainly shaped by the rising sectors such as AI, SaaS, and Fintech, geographical tensions, rising concerns regarding the inflation and interest rates, and challenges with regard to valuation and exit strategies.

Similar to uncertainties in the global economic sphere, which led to a decrease in global startup activity, Turkey has experienced parallel trends. These combined led to a decrease in total funding.

Though there occurred a decrease in total funding, Turkish startup investments reached higher levels in terms of total deal count. Compared to 2022, the total number of deals reached 297 in 2023 from 277 in 2022. Total deal volume, however, has decreased from \$1.84 billion in 2022 to \$497 million in 2023. When the Getir - Mubadala Capital deal whose deal value is not disclosed is taken into account, the magnitude of this decline diminishes significantly.

In 2023, acquisition and seed stage investments accounted for the majority of investment volume in the Turkish startup ecosystem, amounting to 38% and 35%, respectively with approximately \$362 million. In terms of number of deals, seed stage investments led the stage with a total of 243 deals, accounting for c.82% of total deals.


In terms of deal count; Gaming vertical took the lead, sustaining its strong momentum that has been taking place for several years. SaaS, Fintech, Artificial Intelligence, Marketplace, Energy, Ecommerce Enabler, and Healthtech were other active verticals in terms of deal count. SaaS vertical had the highest deal volume with c. \$128 million.

Insider, a leading global SaaS provider, has completed its late stage funding round, receiving \$105 million investment from investors led by Qatar Investment Authority. With the funding round, Insider is expected to strengthen its M&A pipeline in the upcoming years, further solidifying its portfolio with new acquisitions.

2023 has become a stage for large IPOs in the Turkish startup ecosystem. In September 2023, 25% of E-bebek, a prominent player in Baby Toddler Products, went public, raising \$69.5 million. Martı, an innovative mobility company, completed its IPO via a SPAC on Nasdaq, successfully raising \$60 million for 38% equity. Furthermore, Mackolik, raised \$17.2 million in January 2023 via an IPO.

GetirFinans and İş Bankası, a distinguished player in Turkish Banking industry, announced a strategic collaboration. GetirFinans, which will operate within the service model banking, received a \$50 million investment in exchange for 20% equity from İş Bankası.

Alfa Solar Energy acquired 30% of Inavitas for \$12.5 million within the inorganic growth strategy. Other prominent transactions of 2023 include but not limited to the Link Bilgisayar's acquisition (66%) for \$8 million by Re-Pie, Bulls Yatırım Holding, and Lydia Yatırım Holding; and Fazla's early stage investment (14.0%) for \$6 million by investors including 212, Esor Investments, Founder One, Teknoloji Yatırım, TKYB Sermaye Fonu, and Atlantic Labs.






#### Breakdown of startup deals by sub-sector


#### By deal volume | \$ m

#### Leading verticals and prominent deals

- In 2023, the Gaming vertical took the lead with a total of 30 deals. It is followed closely by SaaS with 28 deals, Fintech with 27 deals, and Artificial Intelligence with 23 deals.
- Alfa Solar Energy acquired 30% stake of Inavitas, which offers innovative energy management solutions, for a total of \$12.5 million in November 2023.
- Re-Pie, Bulls Yatırım Holding, and Lydia Yatırım Holding acquired 66% of Link Bilgisayar in December 2023 for \$8 million.

- Fazla, a sustainability startup, received an early stage investment of \$6 million from investors including 212, Esor Investments, Founder One, Atlantic Labs, and TKYB.
- Salus, a healthtech startup, received \$4.7 million in seed funding from Northzone Ventures, 500, Pitch Drive, iş Bankası, Collective Spark, Wamda Capital, and private investors.

**Deal volume (USD million)** 





- Seed Stage investments had the highest number of deals with 243 deals, while Acquisitions had the highest deal volume with \$189m.
- E-bebek, Marti, Mackolik, and Inavitas acquisitions constituted 84% of the total acquisition deal volume with a total of \$159.2m.
- Late Stage investments had the lowest deal count while the Early Stage investment had the lowest deal volume.
- Compared to previous year, number of deals demonstrated an increase of 7%, rising to 297. The deal volume, on the other hand, showed a YoY decrease.
  - Number of Seed Stage investments rose from 215 to 243 while the deal volume showed a YoY decline, amounted to \$173m.
  - In terms of deal number, the acquisitions slightly increased YoY. In terms of deal volume, there was a decline compared to previous year.
  - Early Stage investments declined in terms of both deal number and deal volume YoY.
  - Late Stage investments also demonstrated a decrease when deal count and volume are taken into account.



### Breakdown of startup deals by quarters



- The number of deals in 2023 was 255, marginally decreased compared to 2022. Total deal volume showed a sharp decline, down from \$307.7m in 2023. In quarterly terms, the total deal volume peaked at \$147.5m in Q2 2023.
- Total deal number in Q4 2023 was 74, indicating a decrease compared to the same period in 2022. Total deal volume dropped to \$89.5m in Q4 2023, which corresponded to a decline compared to \$153m in Q4 2022.
- Alongside the decreasing investor appetite, investors have shifted their focus towards small-scaled transactions, resulting a decline in deal volume compared to the previous year.
- Insider's single deal in FY2023 accounted for 34% of the total deal volume. While the transaction details of the late stage investment in Getir by Mubadala Capital were not disclosed, it stood out as one of the significant deals in 2023 regarding its deal size.
- For comparison purposes, only seed stage, early stage and late stage deals are exhibited in the above graph, excluding startup acquisitions. In addition, crypto token based transactions were included in the quarters' deal volume figures.

- In 2023, SaaS was the most prominent vertical constituting the outbound & diaspora deals, followed by Fintech and Artificial Intelligence verticals.
- UK based companies had the highest transaction value for FY2023, followed by Singapore and the USA. In terms of number of deals, USA had the highest number with 32, followed by UK with 13.
- USA based Inflection AI, co-founded by entrepreneur Mustafa Süleyman, has secured a \$1.3 billion in early stage funding from Microsoft, NVIDIA and prominent private investors including Bill Gates and Reid Hoffman. The investment will be used to design and build Inflection AI's first product, Aldriven assistant Pi.
- Airlo, co-founded by Bahadır Özdemir and Abraham Burak, has received a \$60 million early stage investment from a group of investors such as T Capital, Surge, Singtel Innov8, Rakuten Capital, Orange, Liberty Global, LG Technology Ventures, KPN Ventures, I2BF Global Ventures, GO Ventures, e& capital, Antler, Telefónica Innovation Ventures in July.

- Roamless, founded by Ali Gazioğlu, Asım Alp, Emre Demirel, Selim Aykut and Cengiz Öztelcan in 2023, has raised \$2.6 million seed stage investment led by Paribu Ventures, Revo Capital, DeBa Ventures and private investors. The investment will be used to enter into new markets and expand the user base.
- USA based HockeyStack, whose founders include Turkish entrepreneurs Arda Bulut, Buğra Gündüz and Emir Atlı, received an investment of \$2.7 million from Y Combinator, Soma Capital, General Catalyst, Madrona, Uncorrelated Ventures, 645 Ventures, and private investors. HockeyStack plans to introduce new features and boost further development and expansion with the new investment.
  - Development environment management platform Daytona secured \$2 million seed stage investment by 500 Emerging Europe (Fund II), Tiny VC, Silicon Gardens, Firestreak Ventures, Darkmode Ventures, and an undisclosed investor. Daytona aims to expediting product development, expanding its team through hiring, and increasing market penetration efforts.

- Founded in San Diego by Turkish scientist and entrepreneur Dr. İnanç Ortaç, Innovasion Labs PINC has raised \$2m in seed funding from APY Ventures Bilişim Vadisi Fund and a gorup of private investors. The Company develops a revelotutionary energy storage technology.
- Wamo, founded by Yankı Önen, has secured a \$1.5m seed stage investment from Finberg and Re-Pie, bringing their total funding to date a \$6.8m. Wamo plans to discover new markets with the new invesment.
- Segmentify, providing solutions focused on artificial intelligence and big data and founded by Murat Soysal and Ergin Eroğlu, received \$1m investment from Koç Topluluğu Şirketleri 1. - Agrotics, the USA-based agritech company, founded by Güven Akçoban and Mehmet Coka and secured a \$350k in seed funding from Simya VC. Agrotics aims to expand its market network and accelerate its R&D efforts for product development.
- A sustainable agriculture startup Agrovisio, co-founded by Emre Tunalı, Caner Çalık and Sinan Öz, has raised \$284k investment from TürkTraktör, one of the first manufacturing organization in the Turkish automotive sector and the leading company in agricultural mechanization.
- Founded by Ahmet Yasin Acar, Ömer Faruk Yıldırım and Hüseyin Kaan Küçük, Ziv4 Technology received \$71k investment in seed funding from a consortium of private investors. 
