

INFORMATION TEXT REGARDING THE PROTECTION OF PERSONAL DATA IN ACCORDANCE WITH LAW NO. 6698 ON THE PROTECTION OF PERSONAL DATA ("KVKK")

This Information Text has been prepared by the Data Controller KPMG Yönetim Danışmanlığı A.Ş. ("Company") to inform the relevant individuals about the processing, storage, and transfer of their personal data by the Company within the scope of Law No. 6698 on the Protection of Personal Data ("Law").

PROCESSED PERSONAL DATA

The personal data processed by our Company, the purposes of processing your data, the legal reasons for processing, and the methods of collection are listed in the table below:

METHODS OF COLLECTING PERSONAL DATA

Personal data can be obtained directly from the data subject, third parties, and legal authorities. In this context, personal data can be collected through tools such as electronic mail, application forms, and through verbal, written, or electronic communication channels.

SHARING OF PERSONAL DATA WITH THIRD PARTIES

Your personal data mentioned above may be shared with the other member companies of the KPMG International network, including KPMG Yeminli Mali Müşavirlik A.Ş. and KPMG Bağımsız Denetim ve Serbest Muhasebeci Müşavirlik A.Ş., Finansal İnovasyon ve Teknoloji Derneği, suppliers, shareholders, authorized vendors, independent audit organizations, financial institutions, domestic and foreign business partners, storage, archiving, and information technology support companies (server, hosting, program, cloud computing), and legally authorized public institutions and private legal entities within the scope of the data transfer and processing conditions specified in Articles 8

and 9 of the Law, and in compliance with the security and confidentiality principles determined by the legislation.

ENSURING THE SECURITY AND CONFIDENTIALITY OF PERSONAL DATA

In accordance with Article 12 of the KVKK, our Company takes all necessary technical and administrative measures to prevent the unlawful processing and unauthorized access to personal data it processes, and to ensure the protection and preservation of personal data at an appropriate security level. In the event of the unlawful acquisition of processed personal data by others, our Company will promptly notify the data subject and the Board.

DELETION AND DESTRUCTION OF PERSONAL DATA

In accordance with Article 7 of the KVKK, even if personal data has been processed in compliance with the relevant legislation, if the reasons requiring processing cease to exist, personal data will be deleted or destroyed by our Company upon the request of the data subject or ex officio. The procedures and principles related to this will be carried out in accordance with the KVKK and secondary legislation to be created based on this Law.

RIGHTS UNDER THE LAW ON THE PROTECTION OF PERSONAL DATA

In accordance with Article 11 of the KVKK, you can apply to our Company and make requests regarding the following issues:

Learning whether personal data is processed,

Requesting information if personal data has been processed,

Learning the purpose of processing personal data and whether they are used in accordance with this purpose,

Learning the third parties to whom personal data is transferred domestically or abroad,

Requesting correction of personal data if it is incomplete or incorrectly processed and notifying third parties to whom personal data has been transferred in this context,

Requesting the deletion, destruction, or anonymization of personal data if the reasons requiring processing cease to exist and notifying third parties to whom personal data has been transferred in this context,

Objecting to the emergence of a result against the person by analyzing personal data exclusively through automated systems,

Demanding the elimination of damages in case of suffering damage due to the unlawful processing of personal data.

Your requests in your application will be concluded free of charge within thirty days at the latest, depending on the nature of the request. However, if the transaction requires an additional cost for the Company, a fee may be charged in accordance with the tariff determined by the Data Protection Board.

To make your application regarding the processing of your personal data, you can reach the Relevant Person Application Form by clicking [here](#) and deliver it to our Company in writing or by using the registered electronic mail (KEP) address, secure electronic signature, mobile signature, or the

electronic mail address previously notified and recorded in our records. Depending on the nature of the request and the method of application, additional verifications (such as sending a message to your registered phone, calling you, etc.) may be requested by the Company to determine whether the application belongs to you and thus protect your rights. For example, if you apply through the email address registered with the Company, we may use another communication method registered with the Company to contact you and request confirmation that the application belongs to you.
