

# Immigration Application Transparency Statement



**Under the Solicitors Regulation Authority's Transparency Rules, all law firms must provide transparent information regarding the immigration services provided together with the associated costs.**

**We set out below details of UK immigration services that KPMG Law provides to individuals and corporate clients (excluding asylum applications) for the benefit of their employees.**

## Application types and costs

Please see below for the most common visa categories we assist with together with our professional fee range as they apply to individuals. KPMG Law will agree the service(s) to be provided and any estimated fees for assistance at the outset of instruction. If assistance is required with a visa type not listed in the table below, please contact us and we will be happy to assess and provide a quote.

## Disbursements and government fees

The fees in the table above only reference the professional fees and explicitly exclude any disbursements or government fees. Disbursements are costs that we may pay on the client's behalf in relation to their visa application; for example, UK Visas & Immigration application fees. VAT is not applicable to government fees.

Each individual application will incur its own government fees which are set by the UK

government and subject to change. A list of the current applicable application fees is available on the UK Visas and Immigration website: [UK visa fees – GOV.UK \(www.gov.uk\)](https://www.gov.uk/uk-visa-fees).

Costs such as expenses (these are costs which will be incurred by KPMG Law following a client's agreement to reimburse us such as courier or translation fees) will be agreed in advance.

How are our professional fees calculated?

We normally work on fixed fees for a standard visa application. This is based on various factors including:

- how long we anticipate an application will take
- the number of applicants applying (for example, if a main applicant is accompanied by dependants)
- the seniority of team members assisting, and level of expertise required
- the timeframe in which the application must be completed

If there are any complexities, discretionary elements on points of law, or urgency, then we will need to re-evaluate the fixed fee provided or provide some of our services on an hourly rate and/or quote a higher fixed fee (please see the table below for our current hourly rates):

Please note that none of the information regarding the visa application process or costs in this document should be considered as a binding estimate or quotation.

Scope of service

The scope of service provided is tailored to the needs and requirements of each individual client. As a general guide, however, we have outlined the standard scope of our work below:

- Taking instructions from the client;
- Conducting eligibility assessment on available immigration options and/or eligibility for a particular immigration category;
- Providing advice and outlining suggested course of action;
- Providing advice on the application procedure, timeline and required supporting documentation;
- Drafting a Defined Certificate of Sponsorship or Certificate of Sponsorship (specific to certain applications such as Skilled Worker and Senior or Specialist Worker visa);
- Assisting with the collation of documents in support of the visa application;
- Reviewing the application form and supporting documentation;
- Submitting the online application form and booking an appointment if applicable;
- General case preparation/management including answering any queries from the client and/or relevant authority in respect of the application; and
- Providing post visa grant advice and assistance.

The following is excluded under the standard scope of service:

- Accompanying applicants to biometric appointments (this service can be added for an additional fee depending on the location of the appointment and the availability of the service).
- Drafting additional non-immigration related documents in support of the relevant visa application.
- Liaising with other government agencies or third parties for supporting documents on behalf of the client/applicant (this includes booking English language tests and Life in the UK tests).
- Providing translation or interpreting services in respect of any documents and/or representation to authorities. We can however, at the request of the client, obtain fee quotes from translation and/or interpreting companies if required.
- Liaising with UK immigration authorities in relation to individual case updates.



## Time scales

The exact time scales will depend on the visa category under which an application is being prepared and filed, and each individual application's timeline will be impacted by a range of factors such as the complexity of the application; personal circumstances of the client; and number of documents required.

For a standard, non-complex visa application, we can normally finalise the application for submission within two to six weeks. This is subject to the timely provision of all relevant information and documentation by the client and applicant. This does not include UK Visas & Immigration processing times.

Processing times for the application to be decided by UK Visas and Immigration are dependent on the visa category, the expedited service used (where available), and the location the application is submitted. Processing times can vary between two working days and up to six months. Complex applications can be subject to additional processing times.

We are normally able to provide a more accurate estimate on visa processing times once we have details of the application together with the government's most recent processing time estimates and available expedited services.
