P11Ds: End of year reporting of employee benefits



Forms P11D are a statutory requirement for all UK based employers.

#### Your obligations:

- HMRC no longer accept paper based P11D and P11D(b) returns.
- Forms P11D and P11D(b) need to be submitted to HMRC by 6 July following the end of the tax year in which the benefits in kind or taxable expenses were provided.
- Copies of Forms P11D also need to be provided to employees by 6 July.
- Class 1A National Insurance (NIC) is included on the Form P11D(b) and is due for payment to HMRC by 22 July (if paid electronically, earlier if not).
- Forms P11D need to include the value of all benefits in kind and taxable expenses that are not subject to tax via the payroll or included on the PAYE Settlement Agreement (PSA).
- Penalties may become due where Forms are incorrect or incomplete and any associated tax may need to be settled on a grossed-up basis.
- Benefits that are subject to tax via payroll are not included on Forms P11D, but employers need to register to payroll benefits before the start of the tax year (6 April) in order to payroll benefits in that tax year.
- Where agreement to payroll benefits has been reached, the total taxable value needs to be included on the Form P11D(b) at the end of the year so that Class 1A NIC can be settled.


