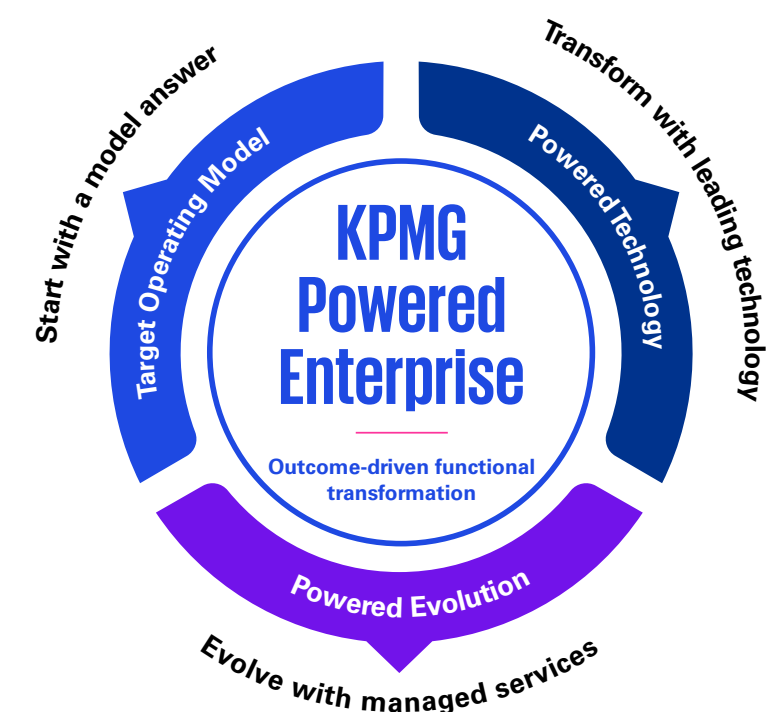

Describes which technologies support what parts of each process.

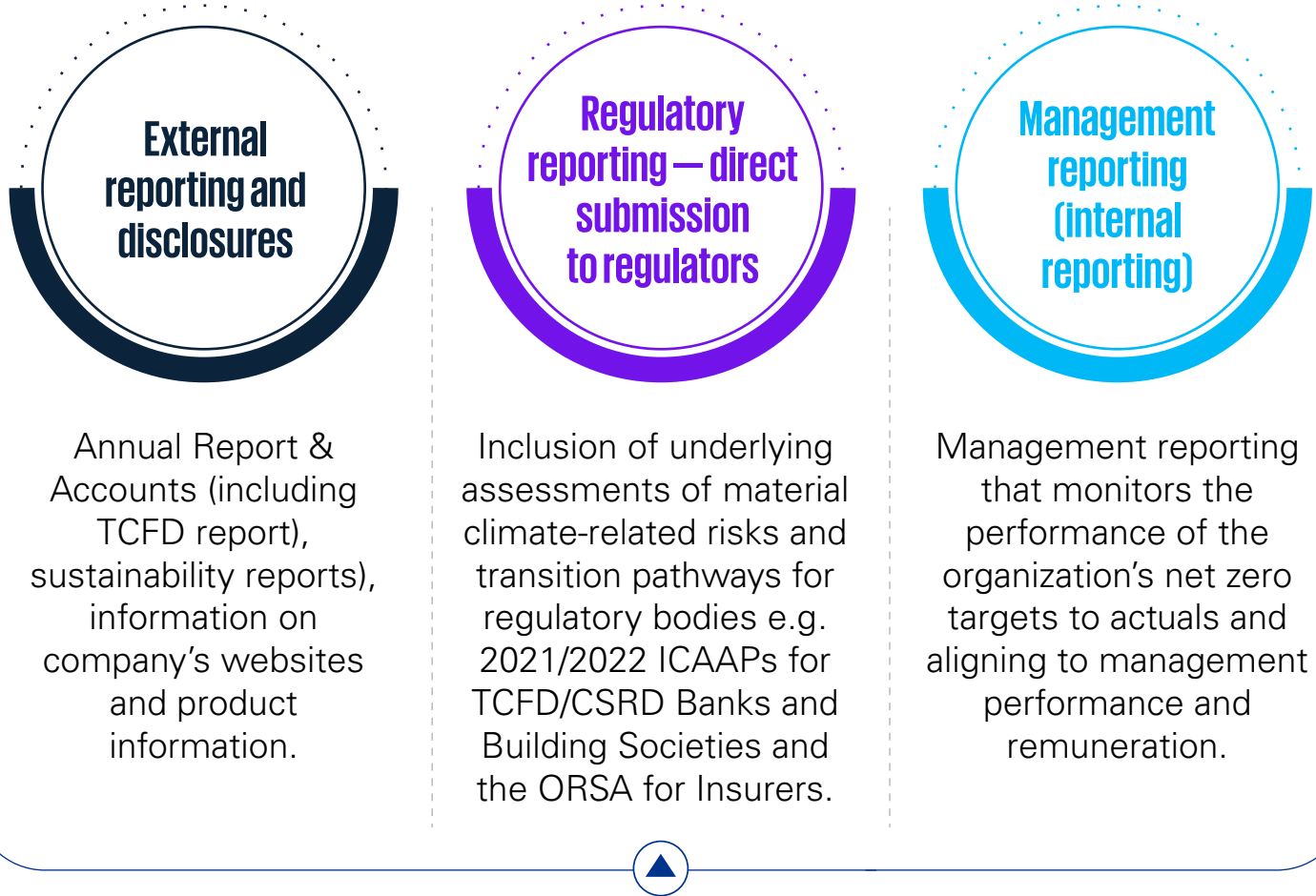

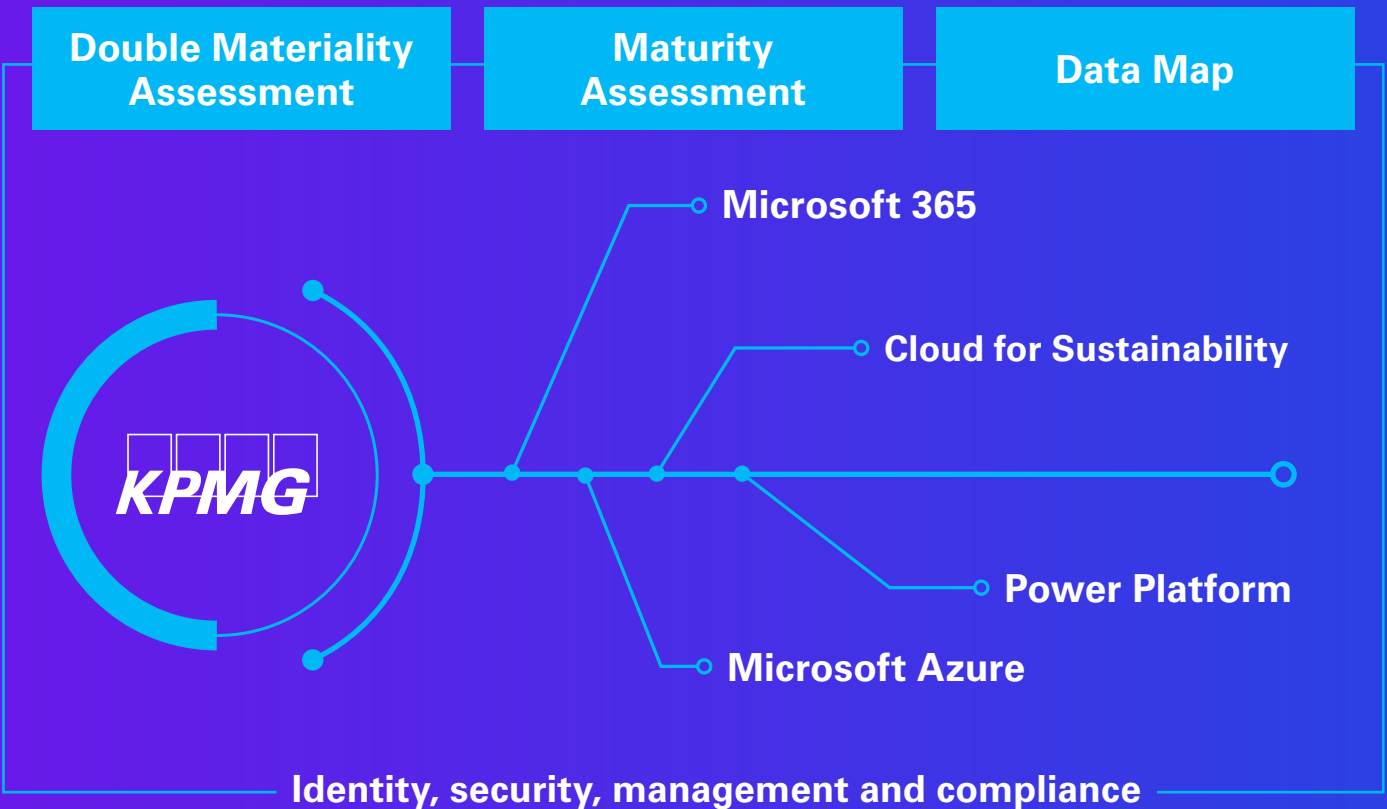

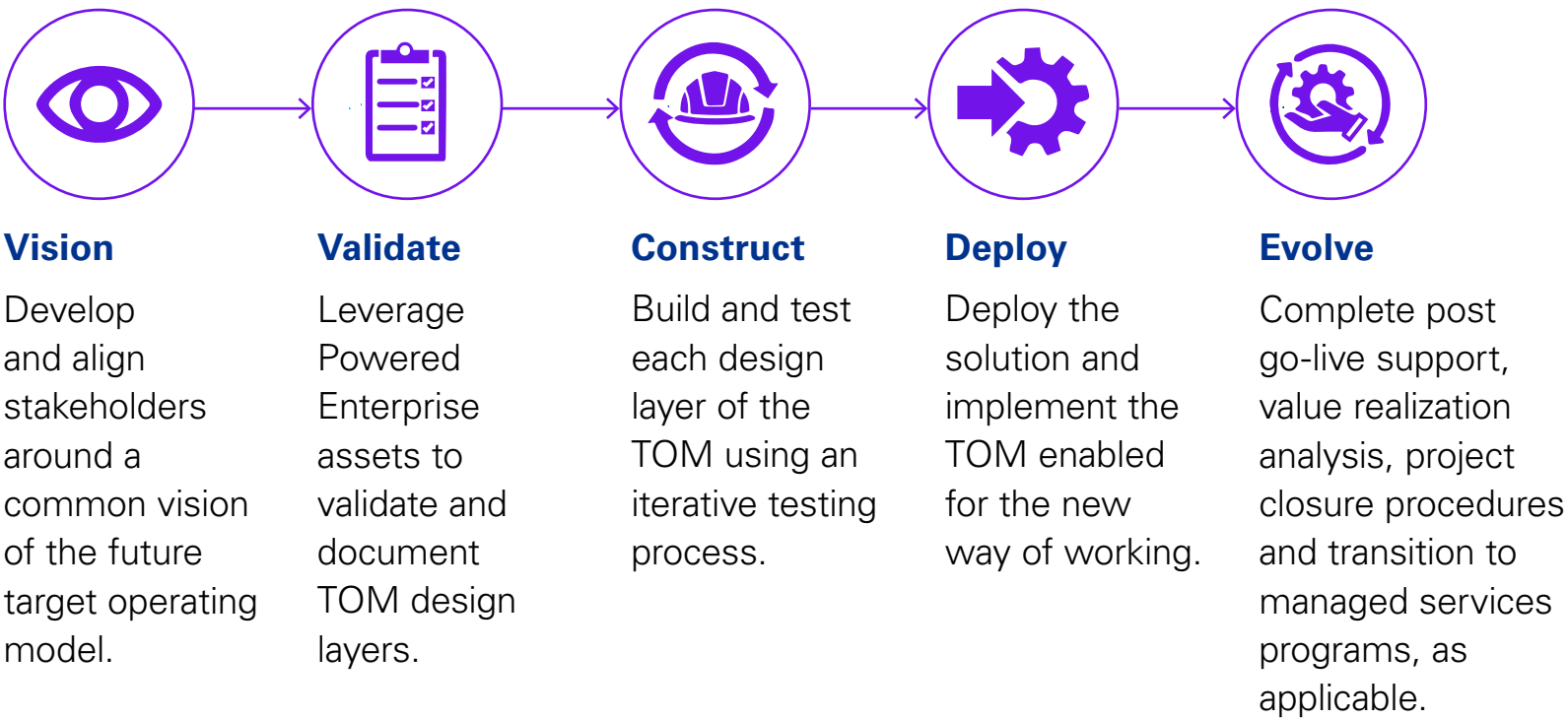
